A BILL FOR AN ACT

RELATING TO FIRE PROTECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Act 83, Session Laws 2 of Hawaii 2012, prohibits counties from requiring the installation or retrofitting of automatic fire sprinkler systems 3 4 in one- and two-family dwellings, except to meet fire fighting 5 road access or water supply requirements. The legislature also finds that prohibiting counties from adopting measures that may 6 7 improve and enhance the ability of residents to protect 8 themselves and their property from fire does not serve the best 9 interest of public health and safety. The legislature further 10 finds that fire sprinkler systems in homes can significantly improve the safety of the occupants, as it has been shown that 11 occupant survivability increases eighty per cent for residential 12 structures protected by fire sprinkler systems. 13 the intensity, severity, and extent of fire in residential 14 15 structures are directly related to residential contents and furnishings, with the volatility of residential contents and 16 17 their arrangement increasing dangerous fire conditions more Those hazards or risks can be addressed and reduced 18 SB LRB 14-0447.doc

- 2 property damage and loss.
- 3 Finally, the legislature finds that county jurisdictions
- 4 may face unique challenges and issues relating to fire
- 5 protection, including but not limited to urban population
- 6 density, proximity of structures and unique residential building
- 7 spacing or setbacks, limited infrastructure, access, and limited
- 8 fire protection response resources. This Act recognizes and
- 9 establishes individual county authority or "home rule" for
- 10 residential fire sprinkler requirements. Local authority over
- 11 residential fire sprinkler systems is recognized, acknowledged,
- 12 and supported by the evidence presented in the National Fire
- 13 Protection Association's Fire Sprinkler Initiative,
- 14 Legislation/Adoptions report that notes that twenty-one states
- 15 lack statewide residential fire sprinkler requirements, but
- 16 instead allow local jurisdictions to require fire sprinklers.
- 17 The purpose of this Act is to repeal Act 83, Session Laws
- 18 of Hawaii 2012.
- 19 SECTION 2. Act 83, Session laws of Hawaii 2012, is
- 20 repealed.
