### A BILL FOR AN ACT

RELATING TO THE COMPOSITION OF THE BOARD OF LAND AND NATURAL RESOURCES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 171-4, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§171-4 Board of land and natural resources; terms and
- 4 qualifications of members of the board; organization; expenses.
- 5 (a) The board of land and natural resources shall be composed
- 6 of seven members, one from each land district and three at
- 7 large, to be nominated and, by and with the advice and consent
- 8 of the senate, appointed by the governor as provided in section
- 9 26-34. The term and removal of a member of the board and the
- 10 filling of a vacancy on the board shall also be as provided in
- 11 section 26-34. There shall be not more than three members on
- 12 the board from the same political party.
- (b) At least one member of the board shall have a
- 14 background in conservation and natural resources, as evidenced
- 15 by:

2		forestry, wildlife conservation, geology,					
3		environmental science, or marine biology; or					
4	(2)	Work history sufficient to demonstrate an appropriate

15	(1)	A college degree in a relevant field, such as Hawaiian					
16		studies, native Hawaiian law, native Hawaiian					
17		traditional and customary practices, or related

20		knowledge in native Hawaiian traditional and customary
