A BILL FOR AN ACT

RELATING TO PASSENGERS RIDING IN BED OF PICKUP TRUCKS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 291-14, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "\$291-14 Pickup trucks; passenger restrictions[-]; 4 liability. (a) No person shall stand in the bed or load-5 carrying area of any motor vehicle commonly known as a pickup 6 truck while the vehicle is in operation. No operator of any 7 pickup truck shall operate the vehicle with a passenger seated in the bed or load-carrying area of the vehicle unless: 8 9 (1)There is no seating available in the cab of the vehicle: 10 11 (2) The side racks of the vehicle are securely attached 12 and the tailboard or tailgate is securely closed; and 13 (3) Every passenger in the bed or load-carrying area of 14 the vehicle is seated on the floor and does not 15 attempt to control unlashed cargo. 16 This section shall not apply to persons or (b) 17 corporations operating a business or businesses that serve the 18 public, who or which are subject to the jurisdiction,



- 19 subject to a fine of \$25 for each violation; provided that any
- 20 person who violates subsection (c) shall be subject to a fine of

- 2 light truck that has a cab on the front part of the vehicle

- 6 bed, and has a maximum gross vehicle weight rating (GVWR) of
