A BILL FOR AN ACT

RELATING TO SCHOOL BUSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that federal and state
- 2 laws require certain motor vehicle drivers and passengers to use
- 3 seat belts because seat belts provide a measure of protection.
- 4 during accidents. Passenger cars, light trucks, and vans are
- 5 required under federal law to have seat belts at all designated
- 6 seating positions. However, neither federal nor Hawaii law
- 7 requires seat belts on school buses that have a gross vehicle
- 8 weight rating of more than ten thousand pounds, which is the
- 9 standard weight of a large school bus.
- 10 Despite increased federal standards for school bus
- 11 passenger safety and crash protection, there are still thousands
- 12 of injuries to children throughout the country each year due to
- 13 school bus accidents. Children suffer both minor and serious
- 14 injuries to their head, neck, back, and stomach when striking
- 15 the roof, windows, seat backs, and other school bus passengers
- 16 during crashes.
- 17 Opponents of seat belts on large school buses argue that
- 18 strong, well-padded, energy absorbing seats and higher seat

- 1 backs compartmentalize passengers during a crash, thereby
- 2 providing adequate safety in frontal crashes. However, a
- 3 comprehensive, in-depth study in 1989 by the Transportation
- 4 Research Board found that the inclusion of seat belts on
- 5 compartmentalized school buses provides additional crash
- 6 protection. Furthermore, a National Highway Traffic Safety
- 7 Administration study found that approximately one-third of the
- 8 fatal crashes between 1977 and 1992 occurred from non-frontal
- 9 and rollover crashes. Compartmentalization is not designed to
- 10 provide protection from non-frontal and rollover crashes. Crash
- 11 test and case study data indicate that seat belts provide
- 12 improved crash protection and are especially beneficial in side-
- 13 impact and rollover school bus accidents.
- 14 The legislature finds that seat belts also reduce other
- 15 types of injuries by restraining children who may otherwise be
- 16 out of their seats. This also helps improve passenger behavior
- 17 and reduce distractions to school bus drivers. In addition,
- 18 seat belts provide other important benefits, such as educating
- 19 children about seat belt use and reinforcing seat belt use in
- 20 motor vehicles.
- 21 The legislature finds that states can require and equip
- 22 school buses to meet a higher safety standard than established

1	under federal law. California, Florida, Louisiana, New Jersey,		
2	and New York have already enacted legislation to mandate seat		
3	belts on large school buses.		
4	The purpose of this Act is to:		
5	(1) Require all school buses imported into the State afte		
6	June 30, 2015, to be fitted with seat belt assemblies		
7	at all designated seating positions;		
8	(2) Require the department of education to adopt rules		
9	requiring the use of seat belt assemblies on school

13	SECTION 2. Chapter 286, Hawaii Revised Statutes, is		
14	amended by adding a new section to part IX to be appropriately		
15	designated and to read as follows:		
16	"§286- School bus safety. (a) Notwithstanding any		
17	other law to the contrary:		
18	(1) All school buses with a gross vehicle weight rating o		
19	more than ten thousand pounds imported into the State		
20	after June 30, 2015, shall be equipped with a seat		
21	belt assembly at each designated seating position; an

2		section 286-26 for a school bus with a gross vehicle		
3		weight rating of more than ten thousand pounds unless		
4		the school bus is in compliance with this subsection.		
5	(b)	As used in this section:		
6	<u>"Sch</u>	ool bus" has the same meaning as in section 286-231.		
7	"Sea	t belt assembly" means a seat belt, including a lap and		
8	shoulder	harness belt, that is in compliance with all applicable		
9	federal s	tandards and installed by or pursuant to the		
10	specifica	tions of the seat belt assembly manufacturer.		
11	(c)	The department of transportation shall adopt rules,		
12	pursuant	to chapter 91, necessary to effectuate the purposes of		
13	this sect	ion.		
14	(d)	The department of education shall adopt rules:		
15	(1)	Requiring the use of seat belt assemblies by pupils on		
16		school buses; and		
17	(2)	Providing appropriate discipline for any pupil who		
18		fails to comply with this section and any rule adopted		
19		regarding the use of a seat belt assembly on a school		
20		bus."		
21	SECT	ION 3. Section 302A-407, Hawaii Revised Statutes, is		
22	amended b	y amending subsection (a) to read as follows:

Description:

Requires school buses that are currently in Hawaii to be retrofitted and equipped with seat belt assemblies by July 1, 2017.
