A BILL FOR AN ACT

RELATING TO TEACHERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 302A-101, Hawaii Revised Statutes, is

Pay all applicable license fees in a timely manner.

Hawaii Teacher Standards Board; Department of Education; State Public Charter School Commission; Teacher Licensing

Description:

Adds a definition of "license" to clarify that teacher licenses are issued by the Hawaii teacher standards board. Clarifies the authority of employers or prospective employers to refuse to issue a certificate for school administrators or revoke a certificate for school administrators under certain circumstances. Makes clarifying amendments to the membership requirements for the Hawaii teacher standards board. Clarifies that charter schools fall under the purview of the requirements of the Hawaii teacher standards board. Makes housekeeping and conforming amendments. (SD1)
