A BILL FOR AN ACT

RELATING TO TEACHERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 302A-101, Hawaii Revised Statutes, is
2	amended by adding two new definitions to be appropriately
3	inserted and to read as follows:
4	" "Department school" means any school that falls within the
5	definition of "public schools", as that term is defined in
6	section 302A-101, and is not a charter school.
7	"License" means the recognition granted by the Hawaii
8	teacher standards board to an individual to practice the
9	profession of teaching. This definition shall not apply to the
10	term "license" as it is used in sections 302A-425 to 302A-427."
11	SECTION 2. Section 302A-601.5, Hawaii Revised Statutes, is
.12	amended by amending subsection (b) to read as follows:
13	"(b) The employer or prospective employer may refuse to
14	employ, and may:
15	(1) Refuse to issue a [teaching or other educational
16	certificate;] certificate for school administrators;
17	(2) Revoke the [teaching or other educational
18	certificate; <u>certificate for school administrators;</u>

(3) Refuse to allow or continue to allow teacher training;
 or

3 4 (4) Terminate the employment of any employee or deny employment to an applicant,

5 if the person has been convicted of a crime, and if the employer 6 or prospective employer finds by reason of the nature and 7 circumstances of the crime that the person poses a risk to the health, safety, or well-being of children. Refusal, revocation, 8 9 or termination may occur only after appropriate investigation 10 and notification to the employee or applicant for employment of 11 results and planned action, and after the employee or applicant for employment is given an opportunity to meet and rebut the 12 finding. Nothing in this subsection shall abrogate any 13 applicable appeal rights under chapters 76 or 89, or 14 15 administrative regulation of the department of education." SECTION 3. Section 302A-801, Hawaii Revised Statutes, is 16 amended by amending subsections (a) to (c) to read as follows: 17 18 There is established the Hawaii teacher standards "(a) 19 board, which shall be placed within the department for 20 administrative purposes only. The board shall consist of fifteen members, including not less than six licensed teachers 21

22 regularly engaged in teaching at the time of the appointment,

2	additional names of qualified nominees from the departments,

5	To the extent possible, the board membership shall reflect
6	[representation of elementary and secondary school personnel
7	from all islands.] a combination of abilities, breadth of
8	experiences, and characteristics that will best serve the
9	diverse interests and needs of elementary and secondary school
10	personnel and the education system in Hawaii from early
11	childhood through higher education. Such considerations shall
12	include but not be limited to reflecting the diversity of the
13	student population, geographical representation, and a broad
14	representation of education-related stakeholders.
15	(c) [Appointed] Notwithstanding any law to the contrary,
16	appointed board members shall serve not more than three
17	consecutive three-year terms. Teacher and educational officer
18	members who retire during a term may serve the remainder of
19	their <u>current</u> term [up to three consecutive three year terms]."
20	SECTION 4. Section 302A-802, Hawaii Revised Statutes, is
21	amended by amending subsections (b) and (c) to read as follows:

15	license and every ten years for an advanced license if the
16	individual continues to:

6 SECTION 8. Section 302A-807, Hawaii Revised Statutes, is
7 amended by amending subsection (d) to read as follows:

8 "(d) Upon revocation of a license, the board may disclose
9 the name, birthdate, social security number, and any other
10 pertinent information about the former holder of the license:

12 (2) To the commission; and

[(2)] (3) For the purpose of exchanging information under
 chapter 315 with other national or state teacher
 certification agencies about school personnel who have

SECTION 9. Section 302A-808, Hawaii Revised Statutes, isamended to read as follows:

19 "§302A-808 Penalty. Any person who engages in the
20 profession of teaching in a public school without first being
21 issued a license or hired on an emergency basis as defined in
22 this chapter shall be fined not more than \$500. Any person who
