A BILL FOR AN ACT

RELATING TO LITERACY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's children 2 and families benefit immensely from literacy programs. 3 importantly, literacy programs assist children with learning to 4 read. However, literacy programs also serve to bridge the gap between home and school in Hawaii's community by building 5 stronger family relationships, improving the academic tone 6 7 within homes, and changing family attitudes toward school. The benefits of literacy programs are evident in the work 8 of existing nonprofits. Read Aloud America is a Hawaii 9 10 nonprofit that brings children and parents together in local 11 schools and motivates them to read. In addition to parents 12 increasing their own reading time, eighty-seven per cent of 13 parents who participated in the program report that their children's voluntary reading time increased, and seventy-one per 14 15 cent report their children spend less time with electronic media. Teachers have also seen encouraging results and report 16 positive changes in student behavior, increased interest in 17 reading, and improved home to school relationships. Since 1999, 18

- 1 Read Aloud America has served eighty-six Hawaii public schools
- 2 and over 315,000 adults and children. Another organization,
- 3 Read to Me International, is also committed to improving child
- 4 literacy. Active on the islands of Oahu, Hawaii, Molokai, and
- 5 Kauai, the nonprofit collaborates with community volunteers to
- 6 educate families about the importance of reading aloud to
- 7 children and raising children who value reading.
- 8 The legislature further finds that child literacy programs
- 9 have previously been supported by funds from the department of
- 10 human services. Currently, valuable literacy programs such as
- 11 Read Aloud America and Read to Me International are suffering
- 12 from a lack of state funding. The governor's council for
- 13 literacy was established in 1987 to work toward a literate
- 14 Hawaii, and Hawaii families continue to need education and
- 15 resources to help children learn to read and families become
- 16 more engaged in their local schools and community.
- 17 The purpose of this Act is to appropriate funds to the
- 18 department of human services to establish a statewide literacy
- 19 program. Utilizing existing programs and nonprofits to provide
- 20 direct services to Hawaii's families, the department of human
- 21 services will administer a literacy program that supports a
- 22 bright future for Hawaii's children and families.
