A BILL FOR AN ACT

RELATING TO COFFEE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the marketers of 2 coffee blends that include Hawaii-grown coffees disclose the
- 3 geographic origin of the Hawaii-grown coffee, but almost never
- 4 disclose the geographic origin of the other non-Hawaii-grown
- 5 coffees also included in the package. This non-disclosure of
- 6 the geographic origin of the non-Hawaii-grown coffee, which is
- 7 usually the vast majority (usually ninety per cent) of the
- 8 coffee in such coffee blends, confuses and misleads consumers.
- 9 Such confusion is particularly likely when the brand names used
- 10 by marketers of these coffee blends contain the terms "Hawaii",
- 11 "Hawaiian", or a Hawaii place name.
- 12 For example, when terms like "Hawaiian", "Kona", or "Maui"
- 13 are used in large type as part of brand names at the top of
- 14 coffee labels, but there is no disclosure of the origin of the
- 15 ninety per cent non-Hawaii grown coffee in a package, consumers
- $16\,$ are often confused and misled into believing they are buying a
- 17 package of Hawaii-grown coffee. These concerns were echoed in

- 1 that "existing labeling requirements for Kona coffee causes
- 2 consumer fraud and confusion and degrades the 'Kona coffee'
- 3 name." Amendments to the relevant statutes are therefore
- 4 necessary to prevent consumer fraud and confusion.
- 5 The purpose of this Act is to conform state coffee labeling
- 6 laws to principles of consumer disclosure and fair marketing by
- 7 requiring express label disclosure of the per cent of coffee not
- 8 grown in Hawaii that is included in coffee blends that contain
- 9 Hawaii-grown coffees.
- 10 SECTION 2. Section 486-120.6, Hawaii Revised Statutes, is
- 11 amended by amending subsection (b) to read as follows:
- "(b) A listing of the geographic origins of the various
- 13 Hawaii-grown coffees and the regional origins of the various
- 14 coffees not grown in Hawaii that are included in a blend [may]
- 15 shall be shown on the label. [If used, this] This list shall
- 16 consist of the term "Contains:", followed by, in descending
- 17 order of per cent by weight and separated by commas, the
- 18 respective geographic origin or regional origin of the various
- 19 coffees in the blend [that the manufacturer chooses to list].
- 20 Each geographic origin or regional origin [may] shall be
- 21 preceded by the per cent of coffee by weight represented by that
- 22 geographic origin or regional origin, expressed as a number



- 1 followed by the per cent sign. When a blend contains one
- 2 Hawaii-grown coffee and one or more coffees not grown in Hawaii,
- 3 this list may use the aggregate per cent by weight of the
- coffees not grown in Hawaii followed by the term "Foreign-Grown 4
- Coffee", in place of listing each respective geographic origin 5
- or regional origin of the coffees not grown in Hawaii. The type
- size used for this list shall [not exceed half] be equal to that 7
- of the identity statement. This list shall appear below the 8
- 9 identity statement[, if included] on the front panel of the
- 10 label."
- 11 SECTION 3. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- 13 SECTION 4. This Act shall take effect on January 1, 2015.

Report Title:

Coffee; Hawaii-grown Coffee; Labeling; Geographic or Regional Origins

Description:

Requires a specific listing of the geographic origins of various Hawaii-grown coffees and the geographic or regional origins of the various coffees not grown in Hawaii that are included in a coffee blend to be listed on the front panel of a label. Permits the aggregate per cent by weight of foreign grown coffees to be listed in lieu of a list of each of the geographic origins of the coffees not grown in Hawaii.
