## A BILL FOR AN ACT

RELATING TO THE PROTECTION OF CHARITABLE ASSETS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The attorney general's role in providing oversight of Hawaii's charitable organizations is recognized 2 under common law and through various provisions of the Hawaii 3 4 Revised Statutes, including provisions in chapters 323D, 414D, 431, 467B, 517E, and, 554, Hawaii Revised Statutes. The purpose 5 of this Act is to codify section 3 of the Model Protection of 6 Charitable Assets Act to grant the attorney general oversight 7 8 over charitable assets regardless of the form in which they are held. 9

SECTION 2. Chapter 28, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

13 "§28- Protection of charitable assets; attorney
14 general's authority. (a) The attorney general shall represent
15 the public interest in the protection of charitable assets and
