A BILL FOR AN ACT

RELATING TO VOTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended 1 by adding a new section to part II to be appropriately 2 3 designated and to read as follows: 4 "§11- Opt-out voter registration. (a) Notwithstanding any law to the contrary, an affidavit on application for voter 5 registration shall be a part of the application associated with 6 7 the issuance of a civil identification card under section 286-301 and a driver's license under section 286-109. 8 (b) An applicant for a civil identification card or 9 driver's license shall fill out the affidavit on application for 10 voter registration unless the applicant clearly indicates on the 11 12 application that the applicant does not wish to register to 13 vote. 14 The examiner of drivers shall not process an application for a civil identification card or driver's license 15 until the applicant either clearly indicates on the application 16

that the applicant does not wish to register to vote or

- completes the portion of the application related to voter 1 2 registration. (d) The examiner of drivers of each county shall provide 3 the respective county clerk with the voter registration 4 information set forth in the affidavit on application for voter 5 registration electronically, within five calendar days. This 6 information shall include a digital copy of the applicant's 7 8 signature. (e) Upon receipt of the electronic information described 9 in subsection (d), the county clerk shall treat the information 10 as constituting an application to register under section 11-15. 11 12 (f) The examiner of drivers for each county shall maintain a copy of any driver's license or civil identification card 13 application, including the affidavit on application for voter 14 15 registration. 16 (g) If an issue related to the electronic transmission of the information described in subsection (d) arises, the county 17 clerk may request that the examiner of drivers deliver relevant 18 19 affidavits on application for voter registration to the county 20 clerk for processing."

SECTION 2. There is appropriated out of the general
