### A BILL FOR AN ACT

RELATING TO HAWAII 3R'S.

	DE II ENACIED DI THE LEGISLATURE OF THE STATE OF HAWAII.
1	SECTION 1. Hawaii 3R's, a Hawaii nonprofit organization,
2	brings private financing and human resources together to tackle
3	the repair and maintenance backlog in Hawaii's public schools.
4	The Legislature finds that for more than a decade, Hawaii 3R's
5	provided a valuable service of bringing much needed improvements
6	to the public schools. Section 235-102.5(b), Hawaii Revised
7	Statutes, enables taxpayers to elect to make donations toward
8	the school-level minor repairs and maintenance special fund by
9	checking off a box on tax returns. When passed, the section was
10	intended to facilitate funding for the repair and maintenance of
11	Hawaii's public schools.
12	The purpose of this Act is to:
13	(1) Rename the Hawaii 3R's school repair and maintenance

- fund as the Hawaii 3R's school improvement fund; and
- (2) Require the transfer of moneys collected pursuant to 15 section 235-102.5(b), Hawaii Revised Statutes, and any 16 **17** other moneys received in the form of grants and 18

- 2 shall also receive moneys transferred to it from the school-
- 3 level minor repairs and maintenance special fund established
- 4 under section 302A-1504.5. The legislature intends that public
- 5 and private sectors review and investigate all potential funding
- 6 sources. The State may appropriate moneys to the fund; provided
- 7 that any appropriations made by the State are not intended to
- 8 supplant the funding of any existing [school-level minor repairs
- 9 and maintenance] programs."
- 10 3. By amending subsection (e) to read:
- "(e) The fund shall not be placed in the state treasury,
- 12 and [the State shall not administer the fund, nor shall] the

- 15 SECTION 3. Section 302A-1504.5, Hawaii Revised Statutes,

- 11 SECTION 5. This Act shall take effect upon its approval.
