A BILL FOR AN ACT

RELATING TO TRAFFIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there have been
- 2 numerous traffic accidents and near-accidents at the
- 3 intersection of Piilani highway and Kulanihakoi street in Kihei,
- 4 Maui. According to the Maui police department, between
- 5 January 1, 2012, and December 31, 2013, there were six major
- 6 crashes, defined as crashes with injuries or property damage
- 7 greater than \$3,000, or both, at this intersection. There were
- 8 also five minor crashes, defined as crashes with no injuries and
- 9 property damage less than \$3,000, during this time at the same
- 10 intersection.
- 11 The legislature further finds that the intersection of
- 12 Piilani highway and Kulanihakoi street will also be the entrance
- 13 to the new Kihei high school, scheduled to open in 2018. Kihei
- 14 is one of Maui's fastest growing communities and with the
- 15 construction, development, and opening of Kihei high school, it
- 16 is more important than ever to make traffic safety, bus safety,
- 17 and pedestrian safety in this area a top priority.

- 1 The legislature additionally finds that the plan, design,
- 2 and construction of a traffic signal at the intersection of
- 3 Piilani highway and Kulanihakoi street will help prevent future
- 4 congestion and ensure traffic, bus, and pedestrian safety.
- 5 Accordingly, the purpose of this Act is to appropriate
- 6 \$500,000 for the traffic signal capital improvement project at
- 7 the intersection of Piilani highway and Kulanihakoi street in
- 8 Kihei, Maui.
- 9 SECTION 2. The director of finance is authorized to issue
- 10 general obligation bonds in the sum of \$500,000 or so much
- 11 thereof as may be necessary and the same sum or so much thereof
- 12 as may be necessary is appropriated for fiscal year 2014-2015
- 13 for the traffic signal at the intersection of Piilani highway
- 14 and Kulanihakoi street in Kihei, Maui.
- The sum appropriated shall be expended by the department of
- 16 transportation for the purposes of this Act.
- 17 SECTION 3. The appropriation made for the capital
- 18 improvement project authorized by this Act shall not lapse at
- 19 the end of the fiscal biennium for which the appropriation is
- 20 made; provided that all moneys from the appropriation
- 21 unencumbered as of June 30, 2016, shall lapse as of that date.
