BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 304A-2168, Hawaii Revised Statutes, is amended to read as follows: 2 "§304A-2168 Hawaii cancer research special fund. 3 There is established within the state treasury a special fund to 4 5 be known as the Hawaii cancer research special fund to be administered and expended by the University of Hawaii. 6 The moneys in the special fund shall be used by the University of Hawaii for the cancer research center of Hawaii's 8 research and operating expenses and capital expenditures. 9 10 [The] Until June 30, 2017, the following shall be deposited into the special fund: 11 12 Moneys collected pursuant to section 245-15; (1) All other fees, charges, and other moneys received in 13 (2) 14 conjunction with programs of the cancer research 15 center of Hawaii; (3) Transfers from other accounts or funds; and 16 17 (4) Interest earned or accrued on moneys in the special
