A BILL FOR AN ACT

RELATING TO AGRICULTURE INNOVATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that Hawaii is in need of 2 a more robust agricultural industry. By supporting and nurturing agricultural innovation, the State will be able to 3 4 develop a more significant food-focused agricultural industry in 5 Hawaii by supporting community dialogue around agricultural 6 innovation and awarding financial resources to businesses, which 7 will, among other things, help facilitate the arrival of new 8 technology to market to further the State's food self-9 sufficiency goals. 10 Accordingly, the purpose of this Act is to establish an 11 innovation grant program for agricultural innovation. 12 SECTION 2. Chapter 206M, Hawaii Revised Statutes, is 13 amended by adding a new part to be appropriately designated and 14 to read as follows: 15 "PART AGRICULTURE INNOVATION GRANT PROGRAM §206M-A Agriculture innovation grant program;

- 17 establishment. There is established the agriculture innovation
- 18 grant program within the department of business, economic

- 7 §206M-B Agriculture innovation grant program;
- 8 applications; awards; rules. (a) Each application for an
- 9 agriculture innovation grant shall show an agribusiness
- 10 incubator program's capacity to mentor and develop start-up
- 11 agricultural businesses focused on feed production, food waste
- 12 recycling, on-farm energy efficiency, and soil health and
- 13 conservation. Institutions of higher education, nonprofit
- 14 organizations, and any firm, partnership, corporation, or
- 15 governmental body or public agency is eligible to apply for an
- 16 agriculture innovation grant.
- 17 (b) The board, in consultation with experts familiar with
- 18 the State's agricultural industry, shall accept and evaluate
- 19 agriculture innovation grant applications, considering each
- 20 applicant's demonstrated ability to provide start-up
- 21 agricultural businesses with:

1	(1)	Assistance from experts in bringing technologies to
2		market, ideally in the form of a large mentor network
3		and local, well-connected, and experienced staff;
4	(2)	Dedicated mentorship where experienced, successful
5		start-up leaders are paired with leaders whose
6		companies are in the early stages of agricultural
7		technology commercialization;
8	(3)	Early vetting and refinement of business models;
9	(4)	Intensive introductory programs for both seed- and
10		growth-stage companies;
11	(5)	Customized training from experts in several areas,
12	·	including customer development, pitching, intellectual
13		property, financial projections, valuation, fund-
14		raising, and team-building; and
15	(6)	Connections to strategic partners both within and
16		outside of the State.
17	Application	ons that show evidence of demonstration funding, cost
18	share, or	additional funds already secured shall receive more
19	favorable	consideration. Such applications shall provide the
20	source, a	mount, timing, and degree of certainty for any funds
21	secured o	utside of the agriculture innovation grant.

1	(c)	Agriculture innovation grants shall be awarded by the
2	board sub	ject to available funds in the agriculture innovation
3	grant fun	d established under section 206M-C.
4	(d)	An applicant who receives an agriculture innovation
5	grant may	apply to renew the grant. Applications for renewal
6	shall inc	lude a report detailing the success of the agribusiness
7	incubator	program.
8	(e)	The board shall adopt rules pursuant to chapter 91 to:
9	(1)	Specify an application procedure and timeline for the
10	i .	agriculture innovation grant program;
11	(2)	Develop a procedure by which to rate applications and
12		award agriculture innovation grants; and
13	(3)	Adopt methods by which to measure the success of each
14		awardee in fulfilling the purpose for which the
15		agriculture innovation grant was awarded, including,
16		as appropriate:
17		(A) The amount and source of follow-on funding;
18		(B) The amount of revenue earned by start-up
19		agricultural businesses supported by the
20		agribusiness incubator program;
21		(C) Job creation resulting from the agribusiness

1	(D) The amount of product grown or sold by volume by
2	start-up agricultural businesses supported by the
3	agribusiness incubator program; and
4	(E) The sustainability of start-up agricultural
5	businesses supported by the agribusiness
6	incubator program.
7	§206M-C Agriculture innovation grant fund. (a) There is
8	created within the state treasury the agriculture innovation
9	grant fund for the agriculture innovation grant program
10	established under section 206M-A.
11	(b) Deposits into the fund may include appropriations to
12	the fund by the legislature and gifts, grants, or donations from
13	public or private sources. Moneys in the fund may be used for
14	direct and indirect costs associated with the agriculture
15	innovation grant program; provided that no more than one per
16	cent of the total amount of moneys annually appropriated from
17	the fund shall be used to offset administrative costs incurred
18	by the board to implement and sustain the agriculture innovation
19	grant program.
20	§206M-D Agriculture innovation grant program; reporting.
21	Following each fiscal year in which the board awards one or more
22	agriculture innovation grants, the board shall submit a report

- 1 to the legislature describing, at a minimum, the agribusiness
- 2 incubator programs receiving a grant, the amount awarded to each
- 3 program, and the results achieved by each program. The report
- 4 shall be submitted no later than twenty days prior to the
- 5 convening of the next regular session.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so much
- 8 thereof as may be necessary for fiscal year 2014-2015 to be
- 9 deposited into the agriculture innovation grant fund.
- 10 SECTION 4. There is appropriated out of the agriculture
- 11 innovation grant fund the sum of \$ or so much thereof as
- 12 may be necessary for fiscal year 2014-2015 for the purposes of
- 13 the agriculture innovation grant program.
- 14 The sum appropriated shall be expended by the department of
- 15 business, economic development, and tourism for the purposes of
- 16 this Act.
- 17 SECTION 5. In codifying the new sections added by section
- 18 2 of this Act, the revisor of statutes shall substitute
- 19 appropriate section numbers for the letters used in designating
- 20 the new sections in this Act.

SECTION 6. This Act shall take effect on July 1, 2014.
