A BILL FOR AN ACT

RELATING TO MEDICAL MARIJUANA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 178, Session Laws of Hawaii 2013, is
- 2 amended by amending section 4 to read as follows:
- 3 "SECTION 4. Section 329-123, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "§329-123 Registration requirements. (a) Physicians who
- 6 issue written certifications shall provide, in each written
- 7 certification, the name, address, patient identification number,
- 8 and other identifying information of the qualifying patient.
- 9 The department of health shall require, in rules adopted
- 10 pursuant to chapter 91, that all written certifications comply
- 11 with a designated form completed by or on behalf of a qualifying
- 12 patient. The form shall require information from the applicant,
- 13 primary caregiver, and primary care physician or board certified
- 14 pain specialist physician as specifically required or permitted
- 15 by this chapter. The form shall require the address of the
- 16 location where the marijuana is grown and shall appear on the
- 17 registry card issued by the department of health. The
- 18 certifying physician shall be required to be the qualifying



- 1 patient's primary care [physician.] physician or a board
- certified pain specialist physician. All current active medical 2
- 3 marijuana permits shall be honored through their expiration
- 4 date.
- 5 (b) Qualifying patients shall register with the department
- 6 of health. The registration shall be effective until the
- 7 expiration of the certificate issued by the department of health
- 8 and signed by the physician. Every qualifying patient shall
- 9 provide sufficient identifying information to establish the
- 10 personal identities of the qualifying patient and the primary
- 11 caregiver. Qualifying patients shall report changes in
- 12 information within ten working days. Every qualifying patient
- 13 shall have only one primary caregiver at any given time.
- 14 department of health shall issue to the qualifying patient a
- 15 registration certificate, and shall charge \$35 per year.""
- 16 SECTION 2. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 3. This Act shall take effect upon its approval.
