### A BILL FOR AN ACT

RELATING TO NATUROPATHIC PHYSICIANS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 455, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "§455- Prescription privileges. To qualify for
- 5 prescription privileges, a naturopathic physician shall fulfill
- 6 the same education, examination, and training requirements as
- 7 physicians or osteopathic physicians licensed under chapter 453
- 8 prior to the prescription, administration, or dispensing of any
- 9 prescription medication. Licensure for the prescription,
- 10 administration, or dispensing of any prescription medication
- 11 shall be issued by the department."
- 12 SECTION 2. Section 455-6, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "\$455-6 Powers and authority of the board. In addition to
- 15 any other powers and duties authorized by law, the board may:
- 16 (1) Adopt and use a seal to be affixed to all official
- acts of the board;

#### Report Title:

Naturopathic Medicine; Naturopathic Physicians; Prescription Privileges

### Description:

Requires naturopathic practitioners to fulfill the same education, examination, and training requirements as physicians or osteopathic physicians licensed under chapter 453 to qualify for prescription privileges, prior to the prescription, administration, or dispensing of any prescription medication. Requires authorization from the department of commerce and consumer affairs for any naturopathic physician wishing to prescribe, administer, or dispense any item on the naturopathic formulary.
