## A BILL FOR AN ACT

RELATING TO MENTAL HEALTH.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State is facing
- 2 a severe shortage of resources to effectively address the needs
- 3 of individuals committed to the custody of the director of
- 4 health or the director of public safety who may require strict
- 5 security and intensive inpatient mental health treatment. Over
- 6 the last twenty years, the Hawaii state hospital in Kaneohe has
- 7 come to serve a forensic population, as virtually every patient
- 8 admitted comes to the hospital by court order. Forensic
- 9 patients are patients who have been charged with a crime, and
- 10 most have been diagnosed with a severe and persistent mental
- 11 illness, substance addiction, or both. Many of the inmates and
- 12 detainees in jails and prisons have a history of violence and
- 13 have significant needs for psychiatric care, including inpatient
- 14 hospitalization.
- 15 The legislature further finds that admissions to Hawaii
- 16 state hospital have increased by over fifty per cent in the past
- 17 two years. The growing need to address this forensic

1 programs. For example, the buildings currently in use at the Hawaii state hospital were designed to serve a population of 2 individuals very different from those who are there at present. 3 4 The purpose of this Act is to: 5 (1)Establish a task force to study the needs of the 6 populations that will be served by the inpatient 7 psychiatric facility and develop a coordinated 8 interagency action plan to implement the services; and 9 Appropriate funds to address identified gaps in (2) 10 facilities and services by developing a suitable 11 inpatient psychiatric facility in which services can 12 be provided for the mentally ill who need stricter 13 security and for inmates and detainees who need a 14 higher level of mental health care. 15 SECTION 2. (a) The department of health shall convene a 16 task force that includes representation from the department of 17 health, judiciary, department of the attorney general, 18 department of public safety, state procurement office, 19 department of accounting and general services, and other

- 1 (b) The task force shall study the needs of the
- 2 populations that will be served by the inpatient psychiatric
- 3 facility. The task force shall develop a coordinated
- 4 interagency action plan to implement services at the new
- 5 inpatient psychiatric facility.
- 6 (c) The department of health shall submit the interagency
- 7 action plan and plans to build a secure inpatient psychiatric
- 8 facility, as described in this Act, to the legislature no later
- 9 than twenty days prior to the convening of the regular session
- 10 of 2015.
- 11 (d) The department of health shall commence building a
- 12 secure inpatient psychiatric facility no later than January 1,
- **13** 2016.
- 14 SECTION 3. The director of finance is authorized to issue
- 15 general obligation bonds in the sum of \$
  - or so much
- 16 thereof as may be necessary and the same sum or so much thereof
- 17 as may be necessary is appropriated for fiscal year 2014-2015
- 18 for the development of a secure inpatient psychiatric facility
- 19 to serve the mentally ill who need stricter security, and
- 20 inmates and detainees who need a higher level of mental health

- 1 The sum appropriated shall be expended by the department of
- 2 health for the purposes of this Act.
- 3 SECTION 4. The appropriation made for the capital
- 4 improvement project authorized by this Act shall not lapse at
- 5 the end of the fiscal biennium for which the appropriation is
- $\mathbf{6}$  made; provided that all moneys from the appropriation
- 7 unencumbered as of June 30, 2016, shall lapse as of that date.
- 8 SECTION 5. This Act shall take effect on July 1, 2014.

## Report Title:

Hawaii State Hospital; Inpatient Psychiatric Facility; Task Force; Appropriation

## Description:

Authorizes the director of finance to issue general obligation bonds for the department of health to develop a secure inpatient psychiatric facility to serve the mentally ill who need stricter security, and inmates and detainees who need a higher level of mental health care. Requires the department of health to establish a task force to study the needs of the populations served by the psychiatric facility and develop a coordinated interagency action plan to implement services at the new inpatient psychiatric facility.
