A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR A WAR MEMORIAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature enacted Act 139, Session Laws
- 2 of Hawaii 2013, directing the office of veterans' services, with
- 3 the assistance of the department of accounting and general
- 4 services, the department of defense, and the state historic
- 5 preservation division, to develop a plan to establish a memorial
- 6 honoring the veterans of the Persian Gulf War, Operation Desert
- 7 Storm, Operation Iraqi Freedom, Operation Enduring Freedom,
- 8 Operation New Dawn, Global War on Terrorism, Homeland Defense,
- 9 and Operation Noble Eagle, and those who have protected our
- 10 borders by land, sea, and air.
- 11 The purpose of this Act is to authorize the issuance of
- 12 general obligation bonds and appropriate the proceeds therefrom
- 13 for the planning, design, and construction of the memorial
- 14 honoring the aforementioned veterans, as proposed and submitted
- 15 by the Gulf War Memorial task force to the legislature in
- 16 January 2014.
- 17 SECTION 2. The director of finance is authorized to issue
- general obligation bonds in the sum of \$ or so much



- 1 thereof as may be necessary and the same sum or so much thereof
- 2 as may be necessary is appropriated for fiscal year 2014-2015
- 3 for the planning, design, and construction of a memorial
- 4 honoring the veterans of the Persian Gulf War, Operation Desert
- 5 Storm, Operation Iraqi Freedom, Operation Enduring Freedom,
- 6 Operation New Dawn, Global War on Terrorism, Homeland Defense,
- 7 and Operation Noble Eagle, and those who have protected our
- 8 borders by land, sea, and air, and replicas of the memorial on
- 9 each neighbor island, as recommended by the Gulf War memorial
- 10 task force pursuant to Act 139, Session Laws of Hawaii 2013.
- 11 The sum appropriated shall be expended by the office of
- 12 veterans' services for the purposes of this Act.
- 13 SECTION 3. The appropriation made for the capital
- 14 improvement project authorized by this Act shall not lapse at
- 15 the end of the fiscal biennium for which the appropriation is
- 16 made; provided that all moneys from the appropriation
- 17 unencumbered as of June 30, 2016, shall lapse as of that date.
- 18 SECTION 4. This Act shall take effect on July 1, 2050.
