A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII AT HILO DISTANCE LEARNING PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that pursuant to
- 2 S.R. No. 150, regular session of 2013, the college of
- 3 agriculture, forestry, and natural resource management of the
- 4 University of Hawaii at Hilo conducted a feasibility study to
- 5 assess the demand for outreach, training, courses, and workshops
- 6 related to advancing agricultural production and processing in
- 7 the rural district of Puna. The findings of the college of
- 8 agriculture, forestry, and natural resource management support
- 9 the need for such outreach, training, courses, and workshops in
- 10 rural communities.
- 11 The legislature further finds that the University of Hawaii
- 12 at Hilo should establish a distance learning program to support
- 13 tropical agriculture and food production in rural communities.
- 14 The program will lead to improved employment and entrepreneurial
- 15 activities in rural communities. The program will also identify
- 16 educational and training needs and design a business incubator
- 17 approach to support job growth in these rural communities.

- 1 Initial focus will be on outreach to increase agricultural
 2 production and processed products for local markets utilizing
 3 emerging engineering programs and may be expanded to other
- 4 training and educational support systems to develop the local
- 5 workforce and entrepreneurs in a rural area. This program may
- 6 serve as a replicable model for distance learning programs that
- 7 can be extended to other rural areas of the State.
- 8 The purpose of this Act is to appropriate funds for a
- 9 distance learning program within the University of Hawaii at
- 10 Hilo to support tropical agriculture and food production in
- 11 rural communities and create appropriate faculty positions.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2014-2015 to
- 15 establish a distance learning program within the University of
- 16 Hawaii at Hilo to support tropical agriculture and food
- 17 production in rural communities and to fund:
- 18 (1) One full-time equivalent (1.0 FTE) community outreach

 19 specialist;
- 20 (2) One full-time equivalent (1.0 FTE) information
- 21 technology specialist; and

- 4 Hawaii at Hilo for the purposes of this Act.
