A BILL FOR AN ACT

RELATING TO THE MODERNIZATION OF THE HAWAII ELECTRIC SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) The public utilities commission shall
2	commence	a proceeding by July 1, 2014, to address the technical,
3	policy, a	nd economic issues associated with the modernization of
4	Hawaii's	electricity grid and shall take into consideration the
5	following:	
6	(1)	Development of a diverse portfolio of renewable energy
7		resources;
8	(2)	Expanded options for customers to manage their energy
9		use;
10	(3)	The manner in which distributed generation shall be
11		allowed access to grid interconnection without
12		discriminatory terms, with fair and reasonable rates;
13		and
14	(4)	Providing fair payment for grid services provided to
15		customers and fair compensation to customers for
16		services provided to the grid by distributed
17		generation.

- 1 The proceeding required under this subsection may encompass one
- 2 or more procedural timelines, as determined necessary and
- 3 appropriate by the public utilities commission.
- 4 (b) The public utilities commission shall submit a report
- 5 of its findings and recommendations to the legislature no later
- 6 than twenty days prior to the convening of the regular session
- 7 of 2016.
- 8 (c) The public utilities commission and the division of
- 9 consumer advocacy within the department of commerce and consumer
- 10 affairs shall be exempt from section 103D-304, Hawaii Revised
- 11 Statutes, in its procurement of any professional services needed
- 12 to conduct the proceeding.
- 13 SECTION 2. There is appropriated out of the public
- 14 utilities commission special fund the sum of \$ or so much
- 15 thereof as may be necessary for fiscal year 2014-2015 for the
- 16 public utilities commission to conduct a proceeding and to draft
- 17 and submit the report pursuant to section 1 of this Act.
- 18 The sum appropriated shall be expended by the public
- 19 utilities commission for the purposes of this Act.
- 20 SECTION 3. There is appropriated out of the public
- 21 utilities commission special fund the sum of \$ or so much
- 22 thereof as may be necessary for fiscal year 2014-2015 for the

- 1 division of consumer advocacy within the department of commerce
- 2 and consumer affairs to represent the interests of all consumers
- 3 in accordance with section 269-51, Hawaii Revised Statutes, in
- 4 the course of the proceeding pursuant to section 1 of this Act.
- 5 The sum appropriated shall be expended by the division of
- 6 consumer advocacy within the department of commerce and consumer
- 7 affairs for the purposes of this Act.
- 8 SECTION 4. This Act shall take effect on July 1, 2050.
