### A BILL FOR AN ACT

RELATING TO FINANCIAL DISCLOSURE STATEMENTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. State board and commission members are required 2 to file annual disclosure statements with the state ethics commission. These records are generally kept confidential. 3 4 Unfortunately, due to limited resources, the state ethics 5 commission does not have the ability to search these records for 6 potential conflicts of interest. The legislature finds that the 7 public is in the best position to identify conflicts of interests and that board and commission members' financial 8 9 disclosure statements should be made public. 10 Section 84-17, Hawaii Revised Statutes, is SECTION 2. 11 amended by amending subsection (d) to read as follows: 12 "(d) The financial disclosure statements of the following 13 persons shall be public records and available for inspection and 14 duplication: 15 (1)
- 15 (1) The governor, the lieutenant governor, the members of the legislature, candidates for and delegates to the constitutional convention, the trustees of the office
