A BILL FOR AN ACT

RELATING TO ILLEGAL PARKING UPON BIKEWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Pursuant to section 291C-123(a), Hawaii Revised SECTION 1. 2 Statutes, "[n]o person shall drive any vehicle other than a bicycle or moped upon a bicycle lane or bicycle path, except 3 upon a permanent or authorized temporary driveway, or park any 4 5 vehicle upon a bicycle lane or bicycle path", subject to 6 enumerated exceptions. Illegal driving or, more frequently, 7 parking upon bicycle lanes and bicycle paths, is a persistent 8 problem in the State. While the maximum fine under section 9 291C-123(b), Hawaii Revised Statutes, is \$500 for any person who 10 drives or parks a vehicle on a bicycle lane or pathway that is 11 not within one of the enumerated exceptions, the minimum fine of 12 \$35 is usually imposed by tickets issued by enforcing officers. 13 This \$35 minimum fine is typically paid by the offending 14 individual via return mail, and a higher fine is rarely imposed 15 by a court of law for any repeat offenses.

16 As the counties move towards greater implementation of a 17 robust network of bicycle lanes and bicycle paths, with a 18 greater emphasis on alternative forms of travel, the current SB2732 SD2 LRB 14-1813.doc

1 minimum fine of \$35 for driving or parking upon bicycle lanes
2 and bicycle paths has proven insufficient to deter motorists
3 from obstructing bicycle lanes and bicycle paths. Obstruction
4 of bicycle lanes and bicycle paths by motorists is a real and
5 present danger and poses a safety hazard to bicyclists and to
6 neighborhoods.

Accordingly, the purpose of this Act is to deter illegal
parking upon bicycle lanes and bicycle paths by increasing the
minimum fine for those respective offenses.

10 SECTION 2. Section 291C-123, Hawaii Revised Statutes, is 11 amended by amending subsection (b) to read as follows:

12 "(b) Any person violating the parking prohibition in
13 subsection (a) shall be fined <u>not less than \$100 but</u> not more
14 than \$500."

15 SECTION 3. This Act does not affect rights and duties that 16 matured, penalties that were incurred, and proceedings that were 17 begun before its effective date.

SECTION 5. This Act shall take effect on July 1, 2050.
