A BILL FOR AN ACT

RELATING TO FOSTER CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 2 licensed and licensed resource family homes, group homes, and
- 3 child-caring institutions, are responsible for the care and
- 4 maintenance of children who are placed in their care. These
- 5 providers incur significant costs in fulfilling this
- 6 responsibility, which includes the cost of providing food,
- 7 shelter, clothing, transportation, daily supervision, medical
- 8 care, personal essentials, school supplies, and a gamut of other
- 9 necessities and services.
- 10 The legislature finds that the department of human services
- 11 renders foster care maintenance payments to foster providers to
- 12 cover the costs incurred in providing such care and maintenance.
- 13 However, foster care maintenance payments have not increased
- 14 since 1990 and the monthly foster care maintenance basic board
- 15 rate of \$529 is inadequate, falling significantly below the cost
- 16 of adequate care and maintenance.

- 1 The purpose of this Act is to increase the minimum monthly
- 2 foster care maintenance basic board rate and the maximum monthly
- 3 difficulty of care rate.
- 4 SECTION 2. Effective July 1, 2014, the department of human
- 5 services shall increase the monthly foster care maintenance
- 6 basic board rate to no less than \$ for payments made
- 7 by the department of human services directly to resource family
- 8 homes, group homes, and child-caring institutions under sections
- 9 17-1617-3 and 17-1617-4, Hawaii Administrative Rules.
- 10 SECTION 3. Effective July 1, 2014, the department of human
- 11 services shall increase the maximum monthly difficulty of care
- 12 rate to no less than \$ for payments made by the
- 13 department of human services directly to resource family homes,
- 14 group homes, and child-caring institutions under sections
- 15 17-1617-3 and 17-1617-4, Hawaii Administrative Rules.
- 16 SECTION 4. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2014-2015 for
- 19 the purposes of this Act.
- The sum appropriated shall be expended by the department of
- 21 human services for the purposes of this Act.

SECTION 5. The department of human services shall submit a 1 2 report to the legislature on: (1) The status and costs of implementing this Act; 3 (2) Any anticipated future costs related to implementing 4 this Act; and 5 (3) The number of foster children affected by this Act, 6 no later than twenty days prior to the convening of the regular 7 session of 2015. 8

SECTION 6. This Act shall take effect on July 1, 2050.
