# A BILL FOR AN ACT

RELATING TO CERTIFICATION OF GAS TANKLESS WATER HEATERS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that certification 2 requirements for the gas tankless, on-demand water heater option 3 for a solar water heating system waiver application must be 4 revised to be more accurate. For quality assurance, the gas tankless, on-demand water heaters should be certified by a North 5 6 American certification organization. 7 SECTION 2. Section 196-6.5, Hawaii Revised Statutes, is 8 amended by amending subsection (a) to read as follows: 9 "(a) On or after January 1, 2010, no building permit shall 10 be issued for a new single-family dwelling that does not include 11 a solar water heater system that meets the standards established **12** pursuant to section 269-44, unless the coordinator approves a
- 13 variance. A variance application shall only be accepted if
- 14 submitted by an architect or mechanical engineer licensed under
- 15 chapter 464, who attests that:
- 16 Installation is impracticable due to poor solar
- 17 resource;

2		cycle cost-benefit analysis that incorporates the
3		average residential utility bill and the cost of the
4		new solar water heater system with a life cycle that
5		does not exceed fifteen years;
6	(3)	A renewable energy technology system, as defined in
7		section 235-12.5, is substituted for use as the
8		primary energy source for heating water; or
9	(4)	A demand water heater device [approved by Underwriters
10		Laboratories, Inc., ] is installed; provided that at
11		least one other gas appliance is installed in the

PURPOSE:

To identify the appropriate organizations that can certify gas tankless on-demand water heaters for a variance from the mandatory solar water heating requirement

for single-family dwellings.

MEANS:

Amend section 196-6.5(a), Hawaii Revised

Statutes.

JUSTIFICATION:

Underwriters Laboratories, Inc., lists manufacturers but not the specific product or model numbers of the gas tankless water heaters. By deleting reference to the Underwriters Laboratories, Inc., and inserting references to a North American certification organizations to include the Canadian Standards Association International; the Air-Conditioning, Heating, and Refrigeration Institute; the Gas Appliance Manufacturers Association; and any other similar organizations, this amendment more accurately assures that gas tankless water heaters still meet performance requirements recognized by a third party certification organization.

purchasing gas tankless water heaters.
