### A BILL FOR AN ACT

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 268, Session Laws of Hawaii 2013, is 2 amended as follows: 3 1. By amending section 2 to read: 4 "SECTION 2. (a) There is established a Hawaii employer-5 union health benefits trust fund task force within the department of budget and finance for administrative purposes to 6 7 consist of the following members: Two members from the house of representatives selected 8 (1) 9 by the speaker of the house of representatives; Two members from the senate selected by the senate 10 (2) 11 president; The director of finance, or the director's designee; 12 (3) One member from the Hawaii Council of Mayors; 13 (4) One member from the Hawaii State Association of 14 (5) Counties; 15

Four members representing public sector unions who 1 (6) 2 shall be invited to participate by the director of 3 finance: One member representing public employee retirees who 4 (7) 5 shall be invited to participate by the director of 6 finance; and 7 Four members representing the respective interests of (8) 8 the four counties who shall be selected by the 9 governor. The director of finance, or the director's designee, shall 10 11 serve as the chairperson of the task force. The task force 12 shall cease to exist on June 30, [2014.] 2015. The members of the task force shall serve without 13 (b) compensation, but shall be reimbursed for expenses, including 14 travel expenses, necessary for the performance of their duties. **15** 16 No member shall be made subject to chapter 84, Hawaii Revised Statutes, solely because of that member's participation as a **17** member of that task force." 18 2. PURPOSE:

The purposes are to extend the current June 30, 2014, sunset for the Hawaii Employer-Union Health Benefits Trust Fund Task Force for an additional year, and to extend the lapse date of the appropriation to support the task force to June 30, 2015, by amending

Act 268, Session Laws Hawaii 2013.

MEANS:

JUSTIFICATION:
