TITLE:

A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE OFFICE OF THE GOVERNOR.

PURPOSE:

To appropriate \$132,000 in general funds for an emergency appropriation for fiscal year 2013-2014 for the Office of the Governor (GOV100).

MEANS:

Emergency appropriation of general funds in accordance with section 9 of article VII of the Hawaii State Constitution.

JUSTIFICATION:

A reduction in the appropriation requested in the State Budget for the Office of the Governor for fiscal year 2013-2014 has necessitated this request.

The general fund appropriation included in this measure has been made in accordance with the statutorily defined appropriation ceiling for the Executive Branch pursuant to section 37-92, Hawaii Revised Statutes. Including appropriations made up to and including the regular and special sessions of 2013, the Executive Branch appropriation ceiling for fiscal year 2013-2014 has already been exceeded by \$385,205,549 or 6.5 per cent. Funding requested in this measure for the operations of the Office of the Governor will result in the appropriation ceiling for the Executive Branch to now be exceeded in fiscal year 2013-2014 by an additional \$132,000 or .0022 per cent. This current declaration takes into account additional general fund appropriations authorized for fiscal year 2013-2014 in this measure only, and does not include other general fund appropriations for fiscal year 2013-2014 that may be authorized for the Executive Branch in other legislation submitted to the Legislature during the regular session of 2014.

Impact on the public: None.

The requested emergency appropriation will ensure that the Office is able to fund its core operations to coordinate with and

assist other state agencies.
