A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH FOR THE DEVELOPMENTAL DISABILITIES DIVISION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that although funds were
- 5 appropriated to the department of health for the developmental
- 6 disabilities division for the fiscal period beginning July 1,
- 7 2013, and ending June 30, 2014, a funding emergency now exists.
- 8 Pursuant to a preliminary injunction issued by the Honorable J.
- 9 Michael Seabright in his Order Granting Plaintiffs' Motion for
- 10 Preliminary Injunction filed December 13, 2010, in Korab, et al.
- 11 v. McManaman, et al., Civil No. 10-00483 JMS/KSC (USDC, Dist. of
- 12 Hawaii), the division is now obligated to provide medicaid title
- 13 XIX program services to the Compact of Free Association (COFA)
- 14 population that is eligible for developmental disabilities
- 15 services using one hundred per cent state funding for the
- 16 current fiscal year.

- 1 This emergency appropriation is necessary for the
- 2 department to continue existing services to meet the needs of
- 3 the COFA population that is eligible for developmental
- 4 disabilities services and to continue funding services mandated
- 5 pursuant to chapter 333F, Hawaii Revised Statutes.
- 6 The purpose of this Act is to make an emergency
- 7 appropriation to provide COFA adults and children who are
- 8 eligible for developmental disabilities services with services
- 9 through medicaid title XIX programs of the developmental
- 10 disabilities division.
- 11 SECTION 3. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$500,000 or so much
- 13 thereof as may be necessary for fiscal year 2013-2014 to provide
- 14 the Compact of Free Association population that is eligible for
- 15 developmental disabilities services with ongoing services of the
- 16 developmental disabilities division of the department of health.
- 17 The sum appropriated shall be expended by the department of
- 18 health for the purposes of this Act.
- 19 SECTION 4. This Act shall take effect upon its approval.
