## A BILL FOR AN ACT

RELATING TO THE ESTABLISHMENT OF AN ENVIRONMENTAL INFORMATION MANAGEMENT OFFICE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the quality of the
2	environment is as important to the welfare of the people of
3	Hawaii as is the economy of the State. The legislature finds
4	that there is increasing demand for the collection and
5	dissemination of state environmental data to the public, to the
6	regulated and permitted community, and to the United States
7	Environmental Protection Agency. The legislature also finds
8	that the development of specialized environmental information
9	management systems can greatly assist the department of health's
10	environmental health administration to provide timely and
11	comprehensive environmental information to the public, increase
12	efficiency, and make more informed decisions to better protect
13	the environment. The legislature finds that an environmental
14	information management office needs to be established to more
15	efficiently and effectively collect and disseminate
16	environmental data. This in turn will greatly assist the
17	environmental programs to make better decisions through the

- 2 current successful software systems, as well as continue to

#### JUSTIFICATION SHEET

DEPARTMENT:

Health

TITLE:

A BILL FOR AN ACT RELATING TO THE ESTABLISHMENT OF AN ENVIRONMENTAL INFORMATION MANAGEMENT OFFICE.

PURPOSE:

To establish an Environmental Information Management Office within the Department of Health.

MEANS:

Add a new chapter to the Hawaii Revised Statutes.

JUSTIFICATION:

Hawaii's environmental health programs currently lack the leadership and management resources in information technology that are required to assure quality data exchanges and transactions that are driven by Hawaii's infrastructure demands and federal and state regulations. Establishing an office and hiring qualified staff will assure resource development for and continued operation of innovations such as online permitting, geospatial mapping, mobile field solutions, and effective coordination of diverse air, water, and soil data functions. Further, establishing an office will promote the federal impetus for environmental programs to reduce the burden of regulatory processes and increase efficiencies in data reporting and accessibility.

Impact on the public: Access to environmental data collected by environmental programs will be easier. Reporting burdens borne by regulated and permitted entities will be lessened.

Impact on the department and other agencies:
The collection and sharing of data by
programs and between programs and other
agencies will be improved allowing for more
efficient and informed decision-making.
