- 9 6:00 p.m. and 6:00 a.m. or while the vehicle is parked on
- 10 private property without authorization of the owner or occupant
- 11 authorizing both the parking of the vehicle there and its use
- 12 for purposes of human habitation.
- 13 (b) As used in this section, "purposes of human
- habitation" includes use as a dwelling place, living abode, or 14
- 15 sleeping place.
- 16 This section does not apply to the parking of vehicles
- 17 and their use for purposes of human habitation in parks, camps,

PURPOSE:

To repeal the requirement that the

Department of Health adopt rules pertaining to human habitation within parked vehicles.

MEANS:

Repeal section 291C-112(d), Hawaii Revised

Statutes (HRS).

JUSTIFICATION:

Department of Health (DOH) rules are unnecessary. Section 291C-112(a), HRS, already bans living in vehicles, with an exception for camping areas and other similar places under section 291C-112(b). Currently, the county and state police enforcement agencies enforce the law regarding parked vehicles on public and private property in response to public safety concerns. There is no need for more

rules and regulations.

The main issue is homelessness and should be addressed more comprehensively, as the State

is attempting now.

Impact on the public: No impact to the
public is anticipated. Existing laws are

sufficient.

Impact on the department and other agencies: This bill has no impact. Existing laws are sufficient.
