BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 323F-6, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "\$323F-6 Records. (a) The corporation and each regional system board shall be subject to the requirements of chapter 5 92F, except that the following categories of government records shall not be required to be disclosed: 6 7 Applications for credentials or staff privileges at (1)8 any of the corporation's medical facilities, records 9 from peer review proceedings, and medical records; and (2) Marketing strategies, strategic plans, evaluations, 10 11 assessments, negotiations, or rates and charges, the 12 disclosure of which would raise the cost of 13 procurement or give a manifestly unfair advantage to 14 any competitor or to any person or entity seeking to 15 do business or proposing to enter into an agreement 16 with a regional system board, the corporation, or any 17 of its facilities.

1	Any person denied access to any such government records
2	shall have available the remedies specified in sections 92F-15
3	and 92F-15.5. Government records protected from disclosure by
4	this section shall be subject to the interagency disclosure
5	provisions of section 92F-19. Section 624-25.5 shall apply to
6	this part notwithstanding anything to the contrary contained in
7	this section.
8	(b) The corporation shall have the authority to set rates
9	for copies of records exempt from chapter 92F. In the case of
10	medical records subpoenaed or in any other manner requested from
11	any of the corporation's regional system facilities, copies
12	shall be paid for by the requestor in an amount based on the
13	facility's actual cost of preparation. The facility's actual
14	cost of preparation shall be no less than \$1 per page and no
15	more than \$2 per page."

18	matured, and proceedings that were begun before it effective
19	date.

PURPOSE:

To establish minimum and maximum fees for copies of medical records from Hawaii Health Systems Corporation and to authorize the Hawaii Health Systems Corporation to set rates for copies of records exempt from chapter 92F, Hawaii Revised Statutes.

MEANS:

Amend section 323F-6, Hawaii Revised

Statutes.

JUSTIFICATION:

The cost of searching and producing a medical record at one of the Hawaii health systems corporation facilities is about \$1.09 per page. This amendment would set a dollar a page as a minimum fee, which, if charged, would eliminate the litigation that has ensued over the cost of producing the records.
