## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 231-4.3, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§231-4.3 Investigators; appointment and powers. (a) The
- 4 director may appoint and commission one or more investigators as
- 5 the exigencies of the public service may require. Persons
- 6 appointed and commissioned under this section shall have and may
- 7 exercise all of the powers and authority and the benefits and
- 8 privileges of a police officer or of a deputy sheriff, including
- 9 the power to arrest[; provided that such powers shall remain in
- 10 force and effect only while in actual performance of their
- 11 duties]. These investigators shall consist of personnel whose
- 12 primary duty is to conduct investigations as directed by the
- 13 director, and as authorized by law. Persons appointed and
- 14 commissioned under this section [shall] may be exempt from
- **15** chapter 76.
- 16 (b) Criminal investigators who are subject to chapter 76
- 17 shall also have and may exercise all of the powers and authority

#### JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO DEPARTMENT OF

TAXATION CRIMINAL INVESTIGATORS.

PURPOSE:

Clarifies that exempt and civil service investigators have the same police powers.

MEANS:

Amend section 231-4.3, Hawaii Revised

Statutes (HRS).

JUSTIFICATION:

The Department's criminal investigation unit is structured in a way that the supervisor is a civil service employee. Section 231-4.3, HRS, only grants police powers to the civil service exempt criminal investigators.

Impact on the public: The public will benefit from the clarification because it will be clear that all Department criminal investigators have the same police powers.

Impact on the department and other agencies:
The department will be benefit because the supervisor of the criminal investigation unit will have the same police powers as the criminal investigators that he or she

supervises.
