## A BILL FOR AN ACT

RELATING TO COMPETITIVE SEALED BIDDING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the process of
- 2 competitive sealed bidding for construction contracts would be
- 3 improved by requiring a procuring agency to include in
- 4 invitations for bids on construction contracts a listing of the
- 5 licenses that are required for contractors and subcontractors to
- 6 perform work under the contract. The legislature further finds
- 7 that this requirement will ensure that work on public
- 8 construction contracts is performed by appropriately licensed
- 9 and qualified contractors and will reduce the number of protests
- 10 that result from missing information.
- 11 The purpose of this Act is to require procuring agencies to
- 12 include in their invitations for bids on construction contracts
- 13 a listing of the licenses that are required for contractors and
- 14 subcontractors to perform work under the contract.
- 15 SECTION 2. Section 103D-302, Hawaii Revised Statutes, is
- 16 amended by amending subsection (b) to read as follows:
- "(b) An invitation for bids shall be issued, and shall
- 18 include a purchase description and all contractual terms and SB LRB 14-0302-1.doc



- 1 conditions applicable to the procurement. If the invitation for
- 2 bids is for construction, it shall include a listing of all
- 3 licenses that are required to perform work under the contract
- 4 and shall specify that all bids include the name of each person
- 5 or firm to be engaged by the bidder as a joint contractor or
- 6 subcontractor in the performance of the contract and the nature
- 7 and scope of the work to be performed by each. Construction
- 8 bids that do not comply with this requirement may be accepted if
- 9 acceptance is in the best interest of the State and the value of
- 10 the work to be performed by the joint contractor or
- 11 subcontractor is equal to or less than one per cent of the total
- 12 bid amount."
- 13 SECTION 3. This Act does not affect rights and duties that
- 14 matured, penalties that were incurred, and proceedings that were
- 15 begun before its effective date.
- 16 SECTION 4. New statutory material is underscored.
- 17 SECTION 5. This Act shall take effect upon its approval.
