A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO ARTICLE III, SECTION 10, OF THE HAWAII CONSTITUTION, TO CHANGE THE LEGISLATIVE REGULAR SESSION FROM MEETING ONCE EACH YEAR TO ONCE EVERY OTHER YEAR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to propose an 2 amendment to Article III, section 10, of the Constitution of the state of Hawaii to require the legislature to convene in regular 3 4 session only in the years ending in an odd number, rather than 5 annually. 6 SECTION 2. Article III, section 10, of the Constitution of 7 the State of Hawaii is amended to read as follows: 8 "SESSIONS 9 Section 10. The legislature shall convene [annually] in 10 regular session at 10:00 o'clock a.m. on the third Wednesday in 11 12 January [-] of each calendar year that ends in an odd number. 13 At the written request of two-thirds of the members to 14 which each house is entitled, the presiding officers of both 15 houses shall convene the legislature in special session. At the 16 written request of two-thirds of the members of the senate, the

president of the senate shall convene the senate in special

- 1 session for the purpose of carrying out its responsibility
- 2 established by Section 3 of Article VI. The governor may
- 3 convene both houses or the senate alone in special session.
- 4 Regular sessions shall be limited to a period of sixty
- 5 days, and special sessions shall be limited to a period of
- 6 thirty days. Any session may be extended a total of not more
- 7 than fifteen days. Such extension shall be granted by the
- 8 presiding officers of both houses at the written request of two-
- 9 thirds of the members to which each house is entitled or may be
- 10 granted by the governor.
- 11 Each regular session shall be recessed for not less than
- 12 five days at some period between the twentieth and fortieth days
- 13 of the regular session. The legislature shall determine the
- 14 dates of the mandatory recess by concurrent resolution. Any
- 15 session may be recessed by concurrent resolution adopted by a
- 16 majority of the members to which each house is entitled.
- 17 Saturdays, Sundays, holidays, the days in mandatory recess and
- 18 any days in recess pursuant to a concurrent resolution shall be
- 19 excluded in computing the number of days of any session.
- 20 All sessions shall be held in the capital of the State. In
- 21 case the capital shall be unsafe, the governor may direct that
- 22 any session be held at some other place."

1 SECTION 3. The question to be printed on the ballot shall be as follows: 2 "Shall the state legislature meet in regular session every 3 4 other year, rather than the current schedule in which it meets every year?" 5 SECTION 4. Constitutional material to be repealed is 6 bracketed and stricken. New constitutional material is 7 8 underscored. 9 SECTION 5. This amendment shall take effect upon compliance with article XVII, section 3, of the Constitution of 10 the State of Hawaii.
