BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 205A-28, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$205A-28 Permit required for development. (a) No
- 4 development shall be allowed in any county within the special
- 5 management area without obtaining a permit in accordance with
- 6 this part.
- 7 (b) No development of units with a time share interest or
- 8 pursuant to a time share plan, as those terms are defined in
- 9 section 514E-1, shall be allowed in any county within the
- 10 special management area."
- 11 SECTION 2. Section 514E-5, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- 13 "§514E-5 Geographic limitations. (a) Except as provided
- 14 in this [section,] subsection, time share units, time share
- 15 plans, and transient vacation rentals are prohibited.
- 16 (1) Existing time share units, time share plans, and
- 17 transient vacation rentals are not impaired by the
- 18 provisions of this section.
