A BILL FOR AN ACT

RELATING TO ONLINE PROTECTION OF INDIVIDUAL RIGHTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 481B-22, Hawaii Revised Statutes, is

 amended by amending subsection (b) to read as follows:

 "(b) Any person who in bad faith registers a domain name
- (a) Ini, person who in add idion region to demonstrate
- 4 that consists of the name of another [living] person, or a name
- 5 substantially and confusingly similar thereto, without that
- 6 person's consent, shall be liable in a civil action by the
- 7 person."
- 8 SECTION 2. Section 481B-23, Hawaii Revised Statutes, is
- 9 amended by amending subsection (a) to read as follows:
- 10 "(a) In any action brought pursuant to this part, it shall
- 11 be the claimant's burden to prove by a preponderance of the
- 12 evidence the person's bad faith intent. In determining whether
- 13 there is bad faith intent pursuant to section 481B-22, a court
- 14 may consider factors, including $[\tau]$ but not limited to $[\tau]$ the
- 15 following:
- 16 (1) The trademark or other intellectual property rights of
- the person, if any, in the domain name;

1	(2)	The person's prior use, if any, of the domain name in
2		connection with the bona fide offering of any goods or
3		services;
4	(3)	The person's bona fide noncommercial or fair use of
5		the mark in a site accessible under the domain name;
6	(4)	The person's intent to divert users from the mark
7		owner's online location to a site accessible under the
8		domain name that could harm the goodwill represented
9		by the mark, either for commercial gain or to tarnish
10		or disparage the mark, by creating a likelihood of
11		confusion as to the source, sponsorship, affiliation,
12		or endorsement of the site;
13	(5)	The extent to which the domain name consists of the
14		legal name of the person or a name that is otherwise
15		commonly used to identify the person;
16	(6)	The person's offer to transfer, sell, or otherwise
17		assign the domain name for financial gain without
18		having used or having an intent to use, the domain
19		name in the bona fide offering of any goods or
20		services or the person's prior conduct indicating a

pattern of such conduct;

1	(/)	The person's provision of material and misleading
2		false contact information when applying for the
3		registration of the domain name, the person's
4		intentional failure to maintain accurate contact
5		information, or the person's prior conduct indicating
6		a pattern of such conduct;
7	(8)	The person's registration or acquisition of multiple
8		domain names that the person knew were identical or
9		confusingly similar to marks of others that were
10		distinctive at the time of registration of the domain
11		names, without regard to the goods or services of the
12		parties;
13	(9)	The person's registration or acquisition of multiple
14		domain names that the person knew were identical or
` 15		confusingly similar to the name of another [living]
16		person, without the person's consent; and
17	(10)	The person sought or obtained consent from the
18		rightful owner to register, traffic in, or use the
19		domain name."
20	SECT	TION 3. Section 481B-24, Hawaii Revised Statutes, is
21	amended b	y amending subsection (a) to read as follows:

- 1 "(a) A person who in good faith registers a domain name
- 2 consisting of the name of another [living] person, or a name
- 3 substantially and confusingly similar thereto, shall not be
- 4 liable under section 481B-22 if the name is used in, affiliated
- 5 with, or related to a work of authorship protected under Title
- 6 17, United States Code, including a work made for hire as
- 7 defined in section 101 of Title 17, United States Code, and if
- 8 the person registering the domain name is the copyright owner or
- 9 licensee of the work, the person intends to sell the domain name
- 10 in conjunction with the lawful exploitation of the work, and the
- 11 registration is not prohibited by a contract between the
- 12 registrant and the named person. The exception under this
- 13 subsection shall apply only to a civil action brought under this
- 14 part and shall in no manner limit the protections afforded under
- 15 the Trademark Act of 1946 (15 U.S.C. 1051 et seq.) or other
- 16 federal or state law."
- 17 SECTION 4. This Act does not affect rights and duties that
- 18 matured, penalties that were incurred, and proceedings that were
- 19 begun before its effective date.
- 20 SECTION 5. Statutory material to be repealed is bracketed
- 21 and stricken.
