BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 84, Hawaii Revised Statutes, is amended

4	" <u>§84-</u> Nepotism. (a) No legislator or employee shall
5	advocate for, appoint, employ, promote, supervise, or advance to

8	daughter, brother, sister, uncle, aunt, first cousin, nephew,
9	niece, grandparent, grandchild, father-in-law, mother-in-law,
10	<u>son-in-law, daughter-in-law, brother-in-law, sister-in-law,</u>
11	stepparent, stepson, stepdaughter, stepbrother, stepsister, half
12	brother, or half sister.
13	(b) This section shall not apply in the event of an
14	emergency resulting from a natural disaster or similar
