A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- The legislature finds that the needs and 1 SECTION 1. 2 enrollment in Hawaii's public schools have shifted and changed over time. Many schools are at capacity and do not have the 3 facilities to adequately handle continued growth, while others 4 struggle to find space to deliver needed programs and services. 5 6 While the department of education is currently addressing these concerns through the construction of portable classrooms and 7 8 multi-track schools, the need to procure the lowest responsive, responsible bidder results in the department of education 9 10 contracting with many different contractors. This creates inefficiencies and inconsistencies among public school campuses 11 in the timeliness of receiving portables, as well as in the 12

- 3 The purpose of this Act is to create a five-year pilot
- 4 project within the department of education to authorize the
- 5 department of education to contract for the design, planning,
- 6 and installation of fourth generation modular design buildings
- 7 to maximize resources and better meet the growing and changing
- 8 needs of Hawaii's public school campuses.
- 9 SECTION 2. (a) There is established within the department
- 10 of education a five-year fourth generation modular design
- 11 building pilot program.
- 12 (b) Under the pilot program, the department of education
- 13 shall enter into a multi-year contract for the design, planning,
- 14 and installation of fourth generation modular design buildings
- on Hawaii's public school campuses.
- 16 (c) For purposes of this Act, the department of education
- 17 shall enter into a multi-year contract. The vendor shall be
- 18 selected by the most appropriate procurement method including
- 19 but not limited to sealed proposals, sealed bids, sole source,
- 20 or other procurement methods as permitted by chapter 103D,
- 21 Hawaii Revised Statutes, to specifically carry out the
- 22 requirements of the pilot project.
