A BILL FOR AN ACT

RELATING TO VOTING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. (a) Notwithstanding any law to the contrary,
- 2 there is established an online absentee voting pilot project for
- 3 a county with a population of
- 4 (b) Whenever used in this Act, unless the context otherwise
- 5 requires:
- 6 "Absentee ballot" or "online absentee ballot" means a ballot
- 7 that is made electronically available to voters pursuant to this
- 8 Act that contains the names of candidates, elective offices to
- 9 be filled, and questions or issues to be voted on.
- 10 "Chief election officer" has the same meaning as in section
- 11 11-1, Hawaii Revised Statutes.
- "County" means a county with a population of
- 13 (c) The voting procedures in this Act shall apply to any
- 14 general, special, recall, primary, or runoff election for which
- 15 absentee voting or voting by mail is available pursuant to
- 16 chapter 15, Hawaii Revised Statutes.
- 17 (d) The county clerk shall establish a process through which
- 18 a voter registered to vote in the county may apply for and



- 1 receive online absentee ballots and other information under this
- 2 Act. The application to register to vote pursuant to this Act
- 3 may require the applicant to provide substantially similar
- 4 information to the information required pursuant to section
- 5 15-4(a), Hawaii Revised Statutes.
- 6 (e) The chief election officer shall develop a standardized
- 7 online absentee-voting system, including an online absentee
- 8 ballot delivery and return system, an online portal through
- 9 which a voter may log in using a personal identification number,
- 10 an online absentee ballot marking system, affirmation and
- 11 declaration materials, and voting instructions, to be used with
- 12 online absentee ballots; provided that the absentee ballot
- 13 return system shall contain a statement substantially similar to
- 14 the statement required in section 15-6, Hawaii Revised Statutes.
- 15 (f) A voter who is registered to vote in the county may
- 16 apply for an online absentee ballot using the absentee ballot
- 17 application process established pursuant to subsection (d) at
- 18 any time but not later than 4:30 p.m. on the day prior to
- 19 the election.
- 20 (g) The county clerk shall request an electronic mail
- 21 address from each voter who applies for an online absentee
- 22 ballot. An electronic mail address provided by a voter shall



- 1 not be made available to the public or any individual or
- 2 organization other than an authorized agent of the county clerk
- 3 and is exempt from disclosure under chapter 92F, Hawaii Revised
- 4 Statutes. The electronic mail address shall be used only for
- 5 official communication with the voter about the voting process,
- 6 including transmitting online absentee ballots and election
- 7 materials, returning online absentee ballots, and verifying the
- 8 voter's mailing address and physical location. The voter shall
- 9 be responsible for informing the county clerk of any changes to
- 10 personal information, including changes to the voter's
- 11 electronic mail address.
- (h) Online absentee ballots shall be made available
- 13 electronically to each voter who successfully applies for an
- 14 online absentee ballot no later than days prior to the
- 15 election.
- 16 (i) A voter who has successfully applied for an online
- 17 absentee ballot pursuant to this Act shall mark the ballot
- 18 electronically with the voter's selections and return the
- 19 absentee ballot to the county election office through the online
- 20 absentee ballot return system. The absentee ballot shall be
- 21 received electronically by the county clerk no later than the
- 22 closing of the polls on election day.



- 1 (j) The voter shall include with the absentee ballot a
- 2 declaration or affirmation by the voter that a material
- 3 misstatement of fact in completing the ballot may be grounds for
- 4 a conviction of perjury or related offenses under the laws of
- 5 the United States or this State.
- 6 (k) Online absentee ballots shall be counted in a manner
- 7 determined by the chief election officer.
- 8 (1) Any person having voted pursuant to this Act shall not
- 9 be entitled to cast a ballot at the polls on election day or to
- 10 vote by absentee ballot pursuant to chapter 15, Hawaii Revised
- 11 Statutes.
- 12 (m) All online absentee ballots electronically received by
- 13 the county clerk after the deadline for receipt as provided in
- 14 subsection (i) shall not be counted by the county clerk.
- 15 (n) Whenever sufficient proof is shown to the county clerk
- 16 that a voter who has returned an online absentee ballot pursuant
- 17 to this Act has died prior to the opening of the polls on the
- 18 date of the election, the voter's online absentee ballot shall
- 19 be deemed invalid and disposed up pursuant to section 11-154,
- 20 Hawaii Revised Statutes. The casting of any such online
- 21 absentee ballot shall not invalidate the election.

- (o) The chief election officer may adopt rules and 1
- 2 procedures, exempt from the requirements of chapter 91, Hawaii
- Revised Statutes, necessary to carry out the purposes of this 3
- 4 Act.
- 5 (p) The chief election officer may contract with a third
- party, in accordance with the requirements of chapter 103D,
- 7 Hawaii Revised Statutes, to assist with carrying out the
- 8 purposes of this Act.
- 9 SECTION 2. There is appropriated out of the general revenues
- 10 of the State of Hawaii the sum of \$ or so much thereof
- as may be necessary for fiscal year 2014-2015 for the planning 11
- 12 and implementation of an online absentee voting pilot project
- 13 pursuant to this Act.
- 14 The sum appropriated shall be expended by the office of
- 15 elections for the purposes of this Act.
- 16 SECTION 3. This Act shall take effect on July 1, 2014;
- 17 provided that section 1 shall apply to all primary, special,
- 18 nonpartisan, and general elections, beginning with the primary
- 19 election of 2016; provided further that this Act shall be
- 20 repealed on December 30, 2020.
