A BILL FOR AN ACT

RELATING TO DISPOSABLE CONTAINERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Hawaii Revised Statutes is amended by
- 2 adding a new chapter to be appropriately designated and to read
- 3 as follows:
- 4 "CHAPTER
- 5 COMPOSTABLE OR REUSABLE DISPOSABLE FOOD SERVICE CONTAINERS
- 6 § -1 Definitions. As used in this chapter:
- 7 "Compostable" means that all materials in the product will
- 8 break down into usable compost in a safe and timely manner
- 9 without leaving any toxic residue.
- 10 "Department" means the department of health.
- 11 "Disposable food service container" means a disposable
- 12 product used by a restaurant or food establishment as packaging
- 13 to serve or transport prepared, ready-to-consume food or
- 14 beverages, including but not limited to plates, cups, bowls,
- 15 trays, and hinged or lidded containers.
- 16 "Expanded polystyrene foam" means blown polystyrene and
- 17 expanded and extruded foams that are thermoplastic petrochemical
- 18 materials using styrene.



- 1 "Prepared food" means food or beverages that are prepared
- 2 to be consumed on the premises of a restaurant or food
- 3 establishment or to be taken out by a consumer from the
- 4 restaurant or food establishment.
- 6 food service containers. (a) Beginning on January 1, 2016,
- 7 restaurants or food establishments serving prepared food using
- 8 disposable food service containers made of expanded polystyrene
- 9 foam shall offer consumers the option of using compostable or
- 10 reusable disposable food service containers provided by the
- 11 restaurant or food establishment.
- 12 (b) Restaurants or food establishments may charge a fee to
- 13 consumers who opt to use compostable or reusable disposable food
- 14 service containers.
- 15 (c) Restaurants or food establishments that provide
- 16 disposable food service containers made of expanded polystyrene
- 17 foam shall display a clearly visible sign informing consumers
- 18 that compostable or reusable disposable food service containers
- 19 are available.
- 20 § -3 Penalties. Any restaurant or food establishment
- 21 that violates section -2 shall receive a written warning from

- 1 the department for an initial violation. Violators shall be
- 2 fined by the department for subsequent violations as follows:
- 3 (1) \$100 for each of a second and third violation;
- 4 (2) \$200 for each of a fourth and fifth violation; and
- 5 (3) \$500 for the sixth and each subsequent violation.
- 6 If the restaurant or food establishment, after receiving written
- 7 notice of a violation from the department, fails to remedy such
- 8 violation within seven days, the restaurant or food
- 9 establishment shall be subject to further penalties as provided
- 10 by this section.
- 11 The department shall undertake administrative action to
- 12 impose, collect, or enforce a penalty under this section.
- 13 § -4 List of packaging. (a) The department shall
- 14 establish and maintain a list of suitable and appropriate
- 15 packaging for prepared food as alternatives to the use of
- 16 expanded polystyrene foam disposable food service containers.
- 17 (b) The department shall post this list on a publicly
- 18 accessible website no later than January 1, 2015. The content
- 19 of the website shall be updated periodically by the department.
- 20 S -5 Rules. The department shall adopt rules pursuant
- 21 to chapter 91 to implement this chapter."
