A BILL FOR AN ACT

AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS FOR THE WAIMEA-PAAUILO WATERSHED PROJECT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Waimea-Paauilo watershed is approximately
- 2 143,000 acres and is located in the northeast part of the island
- 3 of Hawaii. The Waimea-Paauilo watershed project extends to the
- 4 8,000 foot level of Mauna Kea in the south and to the Waikoloa
- 5 stream drainage in the west. Current land use consists of
- 6 irrigated cropland, pastureland, forest reserve, watershed, and
- 7 urban area.
- 8 Most surface water in the area originates on the higher
- 9 slopes of the Kohala mountains. Streams are perennial at the
- 10 headwaters with most of the flow being diverted into lined
- 11 ditches, tunnels, pipelines, and reservoirs or disappearing into
- 12 faults or lava tubes before reaching the coast.
- 13 The major problem with the Waimea-Paauilo watershed is
- 14 inadequate water supply due to insufficient agricultural water
- 15 storage reservoirs and a water collection system with high
- 16 seepage losses. The distribution systems are inadequate for the
- 17 agricultural enterprises in the watershed area. The Waimea-

- 1 Paauilo watershed project would improve agricultural water
- 2 management through more efficient irrigation and livestock water
- 3 distribution systems and protect the soil resources base by
- 4 facilitating improved pasture management. The production of
- 5 crops would be improved since the project would help alleviate
- 6 the drought conditions on the island of Hawaii.
- 7 The purpose of this Act is to authorize the issuance of
- 8 additional general obligation bonds for plans, design, and
- 9 construction of the Waimea-Paauilo watershed project.
- 10 SECTION 2. The director of finance is authorized to issue
- 11 general obligation bonds in the sum of \$ or so much
- 12 thereof as may be necessary and the same sum or so much thereof
- 13 as may be necessary is appropriated for fiscal year 2014-2015
- 14 for design, plans, and construction of the Waimea-Paauilo
- 15 watershed project.
- 16 The sum appropriated shall be expended by the department of
- 17 agriculture for the purposes of this Act.
- 18 SECTION 3. The appropriation made for the capital
- 19 improvement project authorized by this Act shall not lapse at
- 20 the end of the fiscal biennium for which the appropriation is
- 21 made; provided that all moneys from the appropriation
- 22 unencumbered as of June 30, 2016, shall lapse as of that date.
