### A BILL FOR AN ACT

RELATING TO HEALTH CARE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that people immigrate to
- 2 Hawaii from all over the world seeking better living conditions
- 3 and opportunities to work. Hawaii's businesses rely on
- 4 immigrant workers who frequently fill low-paying, unskilled, and
- 5 part-time jobs. Immigrant workers, therefore, contribute to
- 6 society but are vulnerable since they often lack health
- 7 insurance for themselves and their dependents because of work
- 8 status and poverty.
- 9 The legislature further finds that state funds are
- 10 appropriated to the Hawaii immigrant health initiative,
- 11 implemented by the department of human services. This
- 12 initiative ensures that basic health care is available to low-
- 13 income immigrants who meet medicaid eligibility criteria, but
- 14 who are ineligible for medicaid coverage due to the 1996 Welfare
- 15 Reform Act. However, funds currently available are inadequate
- 16 to cover needed services that are provided by community health
- 17 centers and other nonprofit caregivers across the State.

- 1 The legislature further finds that services provided under
- 2 the Hawaii immigrant health initiative are for preventive and
- 3 primary health care delivered by community health centers. The
- 4 medical conditions most frequently treated in this program are
- 5 hypertension, diabetes, pregnancy, and respiratory ailments. If
- 6 these conditions are not addressed through the Hawaii immigrant
- 7 health initiative, costs for uncompensated care delivered at
- 8 hospital emergency rooms and for avoidable hospitalizations will
- 9 be far greater and will affect public and private insurance
- 10 rates for all Hawaii residents.
- 11 The purpose of this Act is to ensure that low-income,
- 12 uninsured immigrants have access to primary and preventive
- 13 health care services.
- 14 SECTION 2. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so much
- 16 thereof as may be necessary for fiscal year 2014-2015 for health
- 17 care services for low-income, uninsured immigrants.
- 18 The sum appropriated shall be expended by the department of
- 19 human services for the purposes of this Act.

1 SECTION 3. This Act shall take effect on July 1, 2014.
