A BILL FOR AN ACT

RELATING TO THE MAALAEA SMALL BOAT HARBOR.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the heavily-used
- 2 Maalaea small boat harbor on Maui serves as a vital connection
- 3 to recreational and commercial ocean activities. It is
- 4 therefore important to keep this small boat harbor in good
- 5 working condition. Unfortunately, the finger piers located
- 6 along the south mole at Maalaea small boat harbor are badly
- 7 deteriorated and beyond repair. Replacement of the wooden
- 8 finger piers is therefore necessary to ensure the continued
- 9 support of the commercial operators who use and depend on access
- 10 to the Maalaea small boat harbor.
- 11 Accordingly, the purpose of this Act is to appropriate
- 12 \$4,000,000 for the capital improvement project along the south
- 13 mole at Maalaea small boat harbor, Maui.
- 14 SECTION 2. The director of finance is authorized to issue
- 15 general obligation bonds in the sum of \$4,000,000 or so much
- 16 thereof as may be necessary and the same sum or so much thereof
- 17 as may be necessary is appropriated for fiscal year 2014-2015

14	the end of the fiscal biennium for which the appropriation is
15	made; provided that all moneys from the appropriation
16	unencumbered as of June 30, 2016, shall lapse as of that date.
17	SECTION 4. This Act shall take effect on July 1, 2014.
