A BILL FOR AN ACT

RELATING TO CHAPTER 328J, HAWAII REVISED STATUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 328J-3, Hawaii Revised Statutes, is
 amended to read as follows:

"[+]§328J-3[+] Prohibition in enclosed or partially
enclosed places open to the public. Smoking shall be prohibited
in all enclosed or partially enclosed areas open to the public,
including but not limited to the following places:

7 (1)Airports and public transportation facilities and 8 vehicles, including buses and taxicabs, under the authority of the State or county, and ticket, 9 10 boarding, and waiting areas of public transit depots, 11 including airports from curb to cabin and including 12 all areas within and immediately in front of and 13 adjacent to passenger terminals and pick-up areas, 14 throughout the airport facility, and up to the passenger loading gates of all state airports; 15 16 (2)Aquariums, galleries, libraries, and museums; Areas available to and customarily used by the general 17 (3)

public, including but not limited to restrooms,

Private residences, except when used as a licensed 1 (1)child care, adult day care, or health care facility; 2 3 (2)Hotel and motel rooms that are rented to guests and are designated as smoking rooms; provided that not 4 more than twenty per cent of rooms rented to quests in 5 a hotel or motel may be so designated. All smoking 6 rooms on the same floor shall be contiguous and smoke 7 from these rooms shall not infiltrate into areas where 8 smoking is prohibited under this chapter. The status 9 10 of rooms as smoking or nonsmoking may not be changed, 11 except to add additional nonsmoking rooms; Retail tobacco stores; provided that smoke from these (3) 12 places shall not infiltrate into areas where smoking 13 is prohibited under this chapter; 14 Private and semiprivate rooms in nursing homes and 15 (4) long-term care facilities that are occupied by one or 16 more persons, all of whom are smokers and have 17 requested in writing to be placed in a room where 18 smoking is permitted; provided that smoke from these 19 20 places shall not infiltrate into areas where smoking is prohibited under this chapter; 21

21	establish	ment, facility, or outdoor area may declare that an



entire establishment, facility, or outdoor area or any part 1 thereof as a place where smoking is prohibited. 2 3 (b) Smoking shall be prohibited in any place in which a sign conforming to the requirements of section [328J-9] 4 5 328J-9(a) is posted." SECTION 4. Section 328J-9, Hawaii Revised Statutes, is 6 7 amended to read as follows: "[+]§328J-9[+] Signs. (a) Clearly legible signs that 8 include the words "Smoking Prohibited by Law" with letters of 9 10 not less than one inch in height or the international "No Smoking" symbol, consisting of a pictorial representation of a 11 burning cigarette enclosed in a red circle with a red bar across 12 13 it, shall be clearly and conspicuously posted in and at the 14 entrance to every place open to the public and place of 15 employment where smoking is prohibited by this chapter by the 16 owner, operator, manager, or other person in control of that 17 place. Clearly legible signs that include the words "Smoking 18 (b) Permitted" with letters of not less than one inch in height or 19 20 the international "Smoking Permitted" symbol, consisting of a pictorial representation of a burning cigarette enclosed in a 21 green circle, shall be clearly and conspicuously posted at the 22 2013-0322 SB SMA.doc

5	SECTION 5. Section 328J-15, Hawaii Revised Statutes, is
6	amended to read as follows:
7	"[-]]§328J-15[-]] County ordinances . (a) Nothing in this
8	chapter shall be construed to supersede or in any manner affect
9	a county smoking ordinance[; provided that the ordinance] that
10	is at least as protective of the rights of nonsmokers as this
11	chapter[\cdot]; provided that no county ordinance shall prohibit or
12	impede smoking on the premises of establishments that meet the
13	exemption requirements of section 328J-7(8).
14	(b) Nothing in this chapter shall prohibit a county from
15	enacting ordinances more stringent than this $chapter[-]_{j}$
16	provided that no county ordinance shall more stringently
17	restrict or prohibit smoking on the premises of establishments
18	that meet the exemption requirements of section 328J-7(8)."
19	SECTION 6. Statutory material to be repealed is bracketed
20	and stricken. New statutory material is underscored.
