A BILL FOR AN ACT

RELATING TO REAL ESTATE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 326, Session
 2 Laws of Hawaii 2012, requires operators of transient
 3 accommodations to provide a local contact whenever an operator
- 4 is not located on the island where a transient accommodation is
- 5 located. The role of the local contact is limited, and any
- 6 services other than those allowed under Act 326, Session Laws of
- 7 Hawaii 2012, can constitute unlicensed real estate activity.
- 8 The purpose of this Act is to clarify the role of a local
- ${f 9}$ contact for operators of transient accommodations.
- 10 SECTION 2. Act 326, Session Laws of Hawaii 2012, section
- 11 2, is amended by amending section 237D- (h) to read as follows:
- 12 "(h) For the purposes of this section:
- "Local contact" means an individual or company contracted
- 14 by the operator of the transient accommodation to [provide
- 15 services required by this section.] serve as the on-site contact
- 16 for the operator, residing on the same island where the
- 17 transient accommodation is located, whose name is required to be

3	(1)	Provides local point of contact services in the case
4		of an emergency or natural disaster, including

9		accommodation; or
10	(3)	Transmits the operator's responses, at the direction
11		of the operator, to on-site inquiries about the

13	Any o	other services provided by a local contact may be
14	subject to licensing requirements under chapter 467. Nothing in	
15	this section shall be deemed to create an employer-employee	
16	relationship between an operator and [its] the operator's local	
17	contact[-] or to authorize a local contact to engage in activity	
18	for which a real estate broker's license or a real estate	
19	salesperson's license is required under chapter 467.	
20	"Rel	evant information" means the operator's name, address,
21	contact i	nformation, registration identification number issued

- 1 pursuant to section 237D-4, and website address if advertising
- 2 or soliciting the transient accommodation on the Internet."
- 3 SECTION 3. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 4. This Act shall take effect upon its approval.
