### A BILL FOR AN ACT

RELATING TO FIREWORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to limit the use of 2 consumer fireworks to cultural purposes only. The Act seeks to discontinue the use of consumer fireworks on three designated 3 holidays, namely, New Year's Eve, Fourth of July, and Chinese 4 5 New Year. This Act would continue to allow display fireworks, 6 articles pyrotechnic, and aerial devices that are conducted by 7 licensed professionals. The use of consumer fireworks causes fires and burn injuries, most frequently harming children. 8 Fireworks produce excessive smoke that contributes to breathing 9 difficulties. Loud fireworks traumatize both war veterans and **10** pets. With the increase in fireworks-related emergency calls, 11 12 public safety agencies are strained to maintain adequate 13 response levels for other critical emergencies. Our State and 14 communities deserve to live in peace and security, without the public safety risk and disruptive impact of consumer fireworks. 15 SECTION 2. Section 132D-2, Hawaii Revised Statutes, is 16 amended by amending the definitions of "consumer fireworks" and 17
