BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 121, Hawaii Revised Statutes, is
- 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 Sergeant Deyson Cariaga service members' life
- 5 insurance reimbursement special fund. (a) There is established
- 6 in the state treasury the Sergeant Deyson Cariaga service
- 7 members' life insurance reimbursement special fund to be
- administered by the department of defense. The special fund 8
- 9 shall consist of legislative appropriations and income from
- 10 investment of the fund. Expenditures from the fund shall be
- made for reimbursing eligible members of the Hawaii national 11
- 12 quard and federal military reserves for premiums paid for
- 13 benefits under the service members' group life insurance program
- 14 pursuant to 38 United States Code section 1965 et seq., as
- 15 amended.
- 16 Eligibility for reimbursement shall be limited to time
- 17 periods in which the member of the Hawaii army or air national

- 1 guard or federal military reserves residing in Hawaii was

- 3 (c) The department of defense shall adopt rules under
- 4 chapter 91 necessary to implement this section."
- 5 SECTION 2. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so
- 7 much thereof as may be necessary for fiscal year 2013-2014 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2014-2015 for deposit into the Sergeant Deyson Cariaga
- 10 service members' life insurance reimbursement special fund.
- 11 SECTION 3. There is appropriated out of the Sergeant
- 12 Deyson Cariaga service members' life insurance reimbursement
- 13 special fund of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2013-2014 and
- 15 the same sum or so much thereof as may be necessary for fiscal
- 16 year 2014-2015 for reimbursing eligible members of the Hawaii
- 17 national guard and federal military reserves for premiums paid
- 18 for benefits under the service members' group life insurance
- 19 program.
- The sums appropriated shall be expended by the department
- 21 of defense for the purposes of this Act.
