A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 127, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"S127- Closing of businesses during tidal wave or
5	tsunami warning. (a) In case of a civil defense warning
6	relating to a tsunami or tidal wave, businesses located in
7	tsunami evacuation areas as indicated on tsunami evacuation maps
8	shall close after the first siren warnings are sounded and until
9	further notice from the appropriate civil defense agency. The
10	applicable businesses shall close no later than hours
11	prior to the estimated arrival of the first wave reaching the
12	shoreline; provided that:
13	(1) Any of the classes of retail trade, as defined in
14	section 486J-1, that operate a station shall exercise
15	prudent discretion and judgment in determining whether
16	to close during a tsunami or tidal wave warning in the
17	interests of providing liquid fuel, as defined in
18	section 486J-1, to the public to facilitate an

1		evacuation; provided further that if the station	
2		remains open, it shall have a sufficient number of	
3		workers on duty to assist with traffic flow in and out	
4		of the business; and	
5	(2)	Any business that sells staples such as food, water,	
6		blankets, and batteries, shall exercise prudent	
7		discretion and judgment in determining whether to	
8		close during a tsunami or tidal wave warning in the	
9		interests of providing staples to the general public	
10		during an evacuation.	
11	<u>(b)</u>	This section shall not apply to a health care provider	
12	who is located in a tsunami evacuation area as indicated on		
13	tsunami evacuation maps; provided that the health care provider		
14	has a current emergency management plan."		
15	SECTION 2. Section 127-1, Hawaii Revised Statutes, is		
16	amended by amending the definition of "disaster relief" to read		
17	as follows:		
18	""Disaster relief" means the preparation for and the		
19	carrying out of all emergency functions, other than functions		
20	for which military forces are primarily responsible, to minimize		
21	and repair injury and damage resulting from disasters caused by		
22	fire, flo	od, tidal wave, tsunami, volcanic eruption, earthquake,

- 1 or other natural causes, or by enemy attack, sabotage, or other
- 2 hostile action. These functions include, without limitation,
- 3 firefighting services, police services, medical and health
- 4 services, rescue, engineering, air raid warning services,
- 5 communications, radiological, chemical, and other special
- 6 weapons defense, evacuation of persons from stricken areas,
- 7 emergency welfare services, emergency transportation, protection
- 8 of important installations, temporary restoration of public
- 9 utility services, and other functions related to civilian
- 10 protection, together with all other activities necessary or
- 11 incidental to the preparation for and carrying out of the
- 12 foregoing functions."
- 13 SECTION 3. New statutory material is underscored.
- 14 SECTION 4. This Act shall take effect upon its approval.
