## A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE TIRES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that pneumatic tires are
- 2 manufactured according to relatively standardized processes.
- 3 Over one billion tires are manufactured worldwide in
- 4 approximately four hundred fifty tire factories. Also, there is
- 5 an international trade in used tires, and many used tires are
- 6 sold each year. Annual global tire sales are approximately
- 7 \$1,700,000,000. The worldwide tire market generates
- 8 \$140,000,000,000 per year. Almost three hundred million tires
- 9 are recycled each year within the United States.
- 10 The legislature further finds that discarded motor vehicle
- 11 tires continue to blight Hawaii's neighborhoods, particularly in
- 12 rural and isolated areas. Abandoned automobiles and tires not
- only take away from the natural beauty of Hawaii but also may
- 14 contain toxic substances such as fuels, metals, oils, and
- 15 coolants that can end up in the ground. When it rains, these
- 16 substances are then flushed into waterways. Mercury is
- 17 particularly dangerous, even in very small quantities, because

- 1 rainfall, endangering aquatic life and public health. The State
- 2 of Hawaii and the county of Hawaii have passed legislation
- 3 mandating the proper disposal and management of waste tires.
- 4 The legislature further finds that Act 173, Session Laws of
- 5 Hawaii 2000, strengthened Hawaii's motor vehicle tire recovery
- 6 program by providing comprehensive requirements relating to
- 7 registration, record keeping, and reporting with effective
- 8 enforcement and penalty provisions. Act 173 also established a
- 9 temporary \$1 motor vehicle tire surcharge.
- 10 The legislature further finds that Hawaii tire importers
- 11 are in the best position to deal with the disposal of used
- 12 tires.
- 13 SECTION 2. Section 342I-23, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "\$342I-23 Motor vehicle tires; collection for recycling.
- 16 (a) Each tire retailer shall:
- 17 (1) Accept, at the point of transfer, in a quantity at
- 18 least equal to the number of new motor vehicle tires
- 19 purchased by a customer, motor vehicle tires offered
- 20 by the customer.
- 21 (2) Post written notice which shall be at least five
- inches by seven inches in size and easily visible to

1	(e) Motor vehicle rental companies shall be permitted to				
2	provide a report and payment of the surcharge annually, with the				
3	year ending December 31, rather than quarterly.				
4	(f) Each tire importer shall accept, acquire, or purchase				
5	used motor vehicle tires annually in an amount that is not less				
6	than ninety-five per cent of the number of motor vehicle tires				
7	sold annually."				
8	SECTION 3. Section 342I-26, Hawaii Revised Statutes, is				
9	amended by amending subsection (d) to read as follows:				
10	"(d) [All importers] Each importer shall maintain records				
11	reflecting the [importation of tires. The] annual number of				
12	motor vehicle tires imported; the annual number of used motor				
13	vehicle tires accepted, acquired, or purchased; and the ultimat				
14	disposition of the used motor vehicle tires. A summary of the				
15	records shall be [made available, upon request, for inspection				
16	by the department.] filed annually with the department of				
17	health."				
18	SECTION 4. Statutory material to be repealed is bracketed				
19	and stricken. New statutory material is underscored.				
20	SECTION 5. This Act shall take effect upon its approval.

## S.B. NO. 566

#### Report Title:

Special Wastes Recycling; Used Tires; Tire Importers

### Description:

Requires tire importers to accept, acquire, or purchase used tires in an annual amount that is not less than ninety-five percent of the number of new tires sold annually by the importer. Requires importers to keep records and report annually to the department of health.
