A BILL FOR AN ACT

RELATING TO LANGUAGE ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that according to the
- 2 United States Census Bureau, American community survey in 2005-
- 3 2009, and estimates by the department of business, economic
- 4 development, and tourism, almost 311,000 of Hawaii's 1,270,000
- 5 people, or twenty-four per cent of Hawaii's population, speak a
- 6 language other than English at home. This includes nearly
- 7 260,000 persons who speak an Asian or Pacific Island language.
- 8 According to the same studies, out of those who speak a language
- 9 other than English at home, 140,791 are limited English
- 10 proficient. According to recent statistics from the non-profit
- 11 Immigration Policy Center, the research and policy arm of the
- 12 American Immigration Council, about eighteen per cent of
- 13 Hawaii's residents are foreign born, while fourteen per cent of
- 14 Hawaii's children with immigrant parents are limited English
- 15 proficient.
- 16 The legislature therefore recognizes that English is not
- 17 the primary language for a significant proportion of Hawaii's
- 18 residents. These people have only a limited ability to read, 2013-0567 SB SMA.doc



- 1 write, speak, or understand English. Language barriers often
- 2 prohibit many residents from fully participating in the
- 3 community. Despite personal, family, community, and government
- 4 efforts to make those with limited English proficiency more
- 5 self-sufficient and productive, these efforts are often
- 6 undermined by lack of access to essential government and
- 7 government-funded services due to the language restrictions of
- 8 Hawaii's limited English proficient population.
- 9 The legislature formerly recognized and acknowledged that
- 10 language is a barrier for those living in Hawaii who have
- 11 identified themselves as being limited English proficient.
- 12 Consequently, the legislature passed Act 290, Session Laws of
- 13 Hawaii 2006, and Act 201, Session Laws of Hawaii 2012, to ensure
- 14 that limited English proficient individuals have meaningful
- 15 access to state-provided and state-funded services in Hawaii.
- 16 These laws established the Hawaii office of language access to
- 17 provide oversight, central coordination, and technical
- 18 assistance to state and state-funded entities in their
- 19 implementation of the requirements of the language access law.
- The language access law requires every state agency and any
- 21 organization that receives state funding and provides services
- 22 to the public to establish a language access plan on how they



- 1 will provide meaningful access to their agency's services,
- 2 including but not limited to social service programs, job
- 3 training and employment assistance programs, fair and impartial
- 4 administrative and other hearings, or emergency assistance.
- 5 These services are to be provided to all of Hawaii's diverse
- 6 population, regardless of what language they speak.
- 7 In an effort to comply with Act 290, Session Laws of Hawaii
- 8 2006, by the end of 2007, plans for twenty-six state departments
- 9 and agencies and more than sixty state-funded entities were
- 10 completed. During the subsequent implementation of these
- 11 language access plans, several major challenges were identified
- 12 as preventing the state and covered entities from providing
- 13 meaningful access in the form of interpretation and translation
- 14 services to limited English proficient individuals, thereby
- 15 limiting the ability of limited English proficient individuals.
- 16 First, there is no comprehensive and centralized system or
- 17 structure in Hawaii to identify qualified language interpreters
- 18 and translators.
- 19 Second, Hawaii has a dearth of competent language
- 20 interpreters and translators available to assist limited English
- 21 proficient individuals. This is critical because a key element
- 22 to the successful implementation of the language access plans is



- 1 the availability of trained and competent interpreters and
- 2 translators so limited English proficient individuals can
- 3 receive competent, timely, and meaningful language access
- 4 assistance to government and government-funded services.
- 5 Third, despite great technological advances, state agencies
- 6 do not have multilingual websites that can help limited English
- 7 proficient individuals access needed information in their own
- 8 language.
- 9 The creation of a statewide language access resource center
- 10 will address the first two needs. A study commissioned by the
- 11 legislature through Senate concurrent resolution No. 67, S.D. 1,
- 12 in 2008, which was undertaken by the office of language access,
- 13 concluded that there is a need and support for the establishment
- 14 of a language access resource center in Hawaii.
- 15 With a statewide language access resource center, Hawaii
- 16 will have a centralized resource that will meet the specific
- 17 needs of government agencies and state-funded entities to comply
- 18 with Hawaii's language access laws and benefit the general
- 19 public, including the limited English proficient population, and
- 20 non-profit and for-profit organizations.
- 21 The purpose of the language access resource center is to:

20	The	establishment of multilingual websites for all state
21	agencies	may contribute greatly to the goal of providing limited

- 1 access information about government services. This Act will
- 2 enable the office of language access to administer a pilot
- 3 project to test the utility and feasibility of this idea since
- 4 the office of language access of is the state agency that is the
- 5 most directly involved in the promotion of language access.
- 6 This Act also appropriates funds needed to establish the
- 7 language access resource center and the multilingual website
- 8 pilot project within the office of language access.
- 9 SECTION 2. (a) The office of language access, in
- 10 collaboration with other state agencies, shall implement a
- 11 multilingual website pilot project. The project shall:
- 12 (1) Explore the utility and feasibility of creating a
- multilingual website to improve language access to
- information provided online for limited English
- proficient persons seeking information about
- 16 government and government-funded services in the state
- of Hawaii; and
- 18 (2) To the extent feasible, produce a multilingual website
- for use by the public for the top twelve limited
- 20 English proficient groups in the state of Hawaii.
- 21 (b) The multilingual website pilot project shall end on
- 22 June 30, . The office of language access shall submit a



- 1 report detailing findings and recommendations, including
- 2 proposed legislation, regarding the pilot project to the
- 3 legislature no later than twenty days prior to the convening of
- 4 the regular session of
- 5 SECTION 3. Section 321C-6, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "[{]\$321C-6[{}] Office of language access; established.
- 8 [$\frac{a}{a}$] There is established within the department of health, for
- 9 administrative purposes only, the office of language access.
- 10 The head of the office shall be known as the executive director
- 11 of the office of language access. The executive director shall
- 12 be appointed by the governor without regard to chapter 76. The
- 13 executive director shall:
- 14 (1) Provide oversight, central coordination, and technical
- assistance to state agencies in their implementation
- 16 of language access requirements under this chapter or
- under any other law, regulation, or guidance;
- 18 (2) Provide technical assistance to covered entities in
- their implementation of this chapter;
- 20 (3) Review and monitor each state agency's language access
- 21 plan for compliance with this chapter;

1	(4)	where reasonable access is not provided, endeavor to
2		eliminate the barrier using informal methods such as
3		conference, conciliation, mediation, or persuasion.
4		Where the language access barrier cannot be eliminated
5		by informal methods, the executive director shall
6		submit a written report with the executive director's
7		opinion and recommendation to the state agency or the
8		covered entity. The executive director may request
9		the state agency or the covered entity to notify the
10		executive director, within a specified time, of any
11		action taken on the executive director's
12		recommendation;
13	(5)	Consult with language access coordinators, the
14		language access advisory council, and state department
15		directors or their equivalent;
16	(6)	Subject to section 321C-3, create, distribute to the
17		State, and make available to covered entities
18		multilingual signage in the more frequently

6	SECTION 4. The executive director of the office of
7	language access shall have the authority to hire personnel
8	necessary to staff the language access resource center and to
9	administer its multilingual website. Such staff shall, at the
10	minimum, consist of one full-time project coordinator, three
11	full-time program specialists, and one full-time clerk. All
12	staff shall, as much as possible, be bilingual.
13	SECTION 5. There is appropriated out of the general
14	revenues of the State of Hawaii the sum of \$ or so
15	much thereof as may be necessary for fiscal year 2014-2015 to
16	establish a statewide language access resource center within the
17	office of language access to allow state agencies and covered
18	entities to provide interpretation and translation services to
19	limited English proficient individuals in accordance with
20	Hawaii's language access laws.
21	The sum appropriated shall be expended by the department of
22	health for the purposes of this Act.
