A BILL FOR AN ACT

RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS FOR HAWAI'I PACIFIC HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds and declares that the
- 2 issuance of special purpose revenue bonds under this Act is in
- 3 the public interest and for the public health, safety, and
- 4 general welfare.
- 5 SECTION 2. Pursuant to part II, chapter 39A, Hawaii
- 6 Revised Statutes, the department of budget and finance, with the
- 7 approval of the governor, is authorized to issue special purpose
- 8 revenue bonds in a total amount not to exceed \$, in
- 9 one or more series, for the purpose of assisting Hawai'i Pacific
- 10 Health, a Hawaii non-profit corporation, the obligated group in
- 11 which Hawai'i Pacific Health is a member, one or more of its non-
- 12 profit affiliates, or any combination thereof, in financing,
- 13 refinancing, or reimbursing costs related to the construction or
- 14 renovation of health care facilities. The legislature hereby
- 15 finds and determines that the financing, refinancing, or
- 16 reimbursing costs related to the construction or renovation of
- 17 health care facilities of Hawai'i Pacific Health, its obligated

- 1 group and its affiliates, constitute a project as defined in
- 2 part II, chapter 39A, Hawaii Revised Statutes, and the financing
- 3 thereof is assistance to a non-profit enterprise.
- 4 SECTION 3. The special purpose revenue bonds and the
- 5 refunding special purpose revenue bonds issued under this Act
- 6 shall be issued pursuant to part II, chapter 39A, Hawaii Revised
- 7 Statutes, relating to the power to issue special purpose revenue
- 8 bonds to assist non-profit enterprises.
- 9 SECTION 4. The department of budget and finance is
- 10 authorized, from time to time, including times subsequent to
- 11 June 30, 2018, to issue special purpose revenue bonds in
- 12 whatever principal amounts the department shall determine to be
- 13 necessary to refund the special purpose revenue bonds authorized
- 14 in section 2 and to refund special purpose revenue bonds
- 15 authorized in this section, regardless of whether the
- 16 outstanding special purpose revenue bonds or refunding special
- 17 purpose revenue bonds have matured or are the subject of
- 18 redemption or whether the refunding special purpose revenue
- 19 bonds shall be bonds for the multi-project programs described in
- 20 section 2. In making this determination, the department shall
- 21 comply with federal law relating to the exemption from federal

- 3 SECTION 5. The authorization to issue special purpose
- 4 revenue bonds under this Act shall lapse on June 30, 2018.
